There is considerable scientific disagreement about the medical hazards of the new pollutants about the effects of DDT now found in human bodies, about the disease due to smog or

about the long range effects of fallout. But the crucial point is that the disagreements exist, for they reveal that we have risked these hazards before we knew what harm they might do. Unwittingly, we have loaded the air with chemicals that damage the lung and the water with substances that interfere with the functioning of the blood. Because we wanted to build nuclear bombs and kill mosquitoes, we have burdened our bodies with strontium 20 and DDT, with consequences that no one can now predict we have been massively intervening without being aware of many of the harmful consequences of our acts until they have been performed and the effects-which are difficult to understand and sometimes irreversible-are upon us. Like the Sorcerer's apprentice, we are acting upon dangerously incomplete knowledge. We are, in effect, conducting a huge experiment on ourselves. A generation hence-too late to help-public health statistics may reveal what hazards are associated with these pollutants.

To those of us who are concerned with the growing risk of unintended damage to the environment, some would reply that it is the grand purpose of science to move into unknown territory, to explore and to discover. They would remind us that similar hazards have been risked before and the science and technology cannot progress without taking some risks. But the size and persistence of possible errors has also grown with the power of science and the expansion of technology.

In the past, the risks taken in the name of technological progress-boiler explosions on the first steamboats or the early injuries from radium were restricted to a small place and a short time. The new hazards are neither local nor brief.

A threat from the outer space is the possibility of deadly radiation from a supernova reaching earth and destroying all life. The supernova phenomenon occurs when an ageing star collapses under its own gravity. In about five billion years from now, the sun will turn into a red giant after using up all hydrogen in the fusion reaction. The solar atmosphere will gradually reach up to the orbit of mars and consequently the entire earth will vaporize and vanish forever. Humans can survive this eventuality only if they manage to migrate to other habitual planet.

Science has ambitious plans for creating space colonies and even terra forming of nearby planets. These alternatives can cut the huge cost involved in space travel. So far, other than Mars no planet in the solar system looks suitable for terra forming. Even an asteroid can be used as a space colony but for such ideas to take concrete shape we need great break throughs in rocket technology like laser engines or the use of anti-matter fuel. At the present level of technology, we can only say that it is not yet time to pack our bags for interplanetary migration. May be by the end of the next century, we will be in a position to identify suitable planets and plan for an exodus from the earth in the eventuality of an impending collision with an asteroid. We cannot postpone the trip indefinitely in view of the ultimate disaster that will vaporise the earth in a few billion years. Some scientists do not give more than 500 million years for life to enjoy its earthly existence before it becomes a desert.

Astronomers estimate that millions of planets in our milky way galaxy may have conditions somewhat conducive to life. At least in a few planets we cannot rule out the possibility of some sort of intelligent life. A project called "SETI" (Search for Extra Terrestrial Intelligence) has already been set up for detecting signs of alien intelligence. The electronic radiations from our T.V. and radio signals might have already reached about 59 light years in radius surrounding us. So far, we have not received any response signal from alien intelligence to the overtures of our electronic beckons. One major constraint is that any alien civilization capable of contacting us should be several millenniums ahead of us in intelligence and technology. The presence of some simple form of life like bacteria alone cannot give us any positive indications of advanced forms of life in any distant planets.

- Until 2005, an ordinary citizen had no access to information held by a public authority. and execution of the schemes and why have the promises made for delivery of essential services to the poor not been fulfilled ? Not surprisingly, the culture of secrecy beginning from colonial rule till the first six decades of independence fuelled rampant corruption, in which a large amount of public money was diverted from development projects and welfare schemes to private use through misuse of power by the authorities. Lack of openness in the functioning of the Government provided a fertile ground for breeding inefficiency and lack of accountability in the working of the public authorities, which, in turn, perpetuated all forms of poverty, including the nutritional, health and educational spheres. In order to rectify the deficiencies in the mechanism for ensuring the reach of entitlements, particularly the basic human needs, the people in general and NGOs, in particular, demanded a greater access to information held by the public bodies, which was acceded to by the Government in 2005.

In this backdrop, the *Right to Information Act, 2005*, referred to as the RTI, hereinafter, was enacted by the National Parliament to dismantle the culture of secrecy, to change the mindset of the bureaucrats and political leaders and to create conditions for taking informed decisions. The major concern of the Act is to allow for greater probity in the functioning of the government departments so as to promote transparency and accountability in the working of the public bodies and contain the scourge of corruption, critical for ensuring good governance.

- It is to be noted that the problem of female foeticide and infanticide has two important dimensions. One is the social dimension which includes norms that prevail in the society which lead the scale against women with regard to education, opportunities and their nobility. The other aspect involves effort to address the problem from the legal point of view. This involves issues like laws and have been made to address the problem and recognition of those who achieve the desired results. This could also include an evolution of the efforts that various NGO's are making in this direction.

The problem/evil of female foeticide lies in societal sensibilities. The Indian middle class is known to succumb to prevalent social norms. Even politics in India is governed by public sentiments. In such a social scenario, it is of paramount importance that a crusade is launched against the prevailing social norms to achieve balanced sex ratio. This can be done only by generating awareness amongst the males about the consequences of extreme forms of gender discrimination like female foeticide. How can we save the girl child from the vicious circle of sex selective abortions ? Do we want for revaluation or for that illusive entity called political 'will' to be forged or for the miracle of total enforcement of the Pre-Natal Diagnostic Techniques (Regulation and Prevention of Misuse) Act, 1994. Should we expect a change of heart regarding foeticide ? Service providers, who eye profits at all costs ? A girl child's situation is akin to an analogy of physics, where a particle is in a well. Imagine a ball in bowl shaped pit. The walls of the pit provide the barrier that the ball must overcome in order to get out of the pit. The higher the barrier the more difficult it is for the ball to overcome it. An extreme example of this is the black hole where the barrier is so high that even light is unable to escape out of it.

It is necessary to map the contours of the problem by locating the epic centres of female child deficits. In the longer term, there is need to create objective conditions so as to minimise the feeling of "unwantedness" in a girl child. This is necessary as a medium of economic and physical security for women. At the same time civil society must also debate the ethical dimension of sex based elimination of a segment of the population. The question is regarding current model of development where discrimination necessarily appears to accompany development. However, success stories of alternative development must be provided viability and highlighted as role models for the society to follow. It is to be noted that roots of sex-selective elimination need to be traced to the preception about unwantedness of the girl child and tackled at that level. These preceptions are shaped primarily through viewing a daughter as a liability in economic and physical security sense. A substantial part of this preception is shaped by the prevailing status of women.

Child labour is a serious means to the society and to our country which needs effective measures for eradication. In absence of fair work culture in India the employers sole attention is towards the maintenance of machine and their production. Due to strict compliance with statutory provisions. Children are often abused

by way of child labour. No doubt, we have labour problems but it should not be sorted out at the cost of children's life. A child is the father of man. They deserve proper health, care, education and upbringing. So that they can unfold their potential and talent to provide the nation new horizons. Due to poverty and illiteracy the children and with their guardians are unaware of their rights. The socio-economic status of child labour is far below the status of his employer. As they cannot exercise their rights freely, the employer takes advantage of their economic condition and illiteracy and dictates his own terms and conditions with regard to wages, hours of work, leave etc. The child labour is left with no choice but to accept such terms because work is the only means of earning his livelihood.

Almost one third of the world population, comprises of children. Children need to be protected. Children are important components of the society and also the potentials of tomorrow. First time during Geneva declaration of rights of the child, 1924 the importance of children's protection was stated and emphasized. The concept of safeguarding the children was recognized in the Universal Declaration of Human Rights, 1948 and in the statutes of specialised agencies of U.N.O. Article 25 of the Universal Declaration of Human Rights, 1948, provides that motherhood and childhood are entitled to special care of assistance. All children whether legitimate or illegitimate shall enjoy the same social protection. Article 26 of the said declaration provides right to free and compulsory elementary education to children.

It is a fact that the Constitution of India was drafted almost at the same time. When the Universal Declaration of Human Rights was adopted by the international community. The Constitution of India guarantees most of Human Rights which were provided



in the two conventions in 1966. The provisions of part-III of the Indian Constitution are legally enforceable whereas provisions contained in part-IV are non-justiciable. It is states' duty to make policy to ensure that at tender age the children are not abused. Article 23 of the Constitution imposes prohibition on traffic in human beings and bans other forms of forced labour. Taxation is one of the important devices by which a Government collects money required for running the administration and the continuation of the development and public welfare projects. It is ultimately the people themselves who have to share the burden of development activities. That is why the power of mobilization of resources and the distribution of expenditure generally rests

with the chosen or accepted representatives of the people. While imposing taxes the Government always takes care to see that taxes are imposed according to the paying capacity of the individuals or classes being taxed.

Taxation is of two types : direct and indirect. In direct taxation, a person who is taxed has to pay the tax himself. Direct taxes include taxes like house tax, income tax, octroi, entertainment tax, etc. In the case of indirect taxes, the impact of taxation is on one person while the incidence is on another. The imposition of excise duty on sugar is an example of indirect taxation. The consumer has to pay the tax, but he does not directly pay it; he pays it through the producer.

Direct and indirect systems of taxation have both their advantages as well as disadvantages. Direct taxes are more equitable as their rate is generally varied to make the tax conform to the citizens' ability to pay. They are economical, as the cost of collection is small. They can be calculated with a fair degree of correctness. On top of it all they create a civic consciousness among the tax payers. A man who pays a direct tax has the feeling that he is contributing something towards the development of the country. He starts taking a keen interest in the affairs of the country and becomes conscious of his rights and duties. They have, however, their own demerits. They are inconvenient to pay. They have to be paid in a lumpsum. Many of these taxes can be evaded and this encourages people to be dishonest.

Indirect taxes, on the other hand, are convenient to pay. People prefer to be taxed 'in the dark', while paying indirect taxes, the tax payer does not feel that he is paying anything extra. Indirect taxes can also have a beneficial social effect. Harmful drugs and intoxicants can be taxed heavily to reduce their consumption. But they, too, have their limitations. They are uncertain and inelastic. They tax the rich and the poor alike. They do not develop any civic consciousness in the tax-payer. For their collecting a big staff has to be maintained.

Modernisation and westernisation have changed the status of women and spelt liberation for the average Indian women. Upliftment of status of Indian women in our country is a searing issue that can only become a reality if suitable laws are incorporated and enforced. The relevant laws must be enforced with the aim to bring attitudinal change in society.

In this context the national plan for the period 1988-2000 has made provisions to ensure, that women "catch up with the mainstream" of national life. Special legislation for women should be passed to strengthen the needs where existing

policies and programmes do not serve special needs of women, they ought to be re-incorporated or amended. Where the benefits of these programmes do not reach out urban and rural women special laws should be made to increase effectiveness.

Now, the time has arrived for reviewing and amending all existing statutes and procedures which discriminate against women. A woman's Commission for women's rights should be appointed to follow and monitor enforcement of legislation in this regard. It will definitely yield expected results in this field. But our past experiences have shown that the national efforts for cause of women and abolition of discrimination against them could not reach all sections of society, particularly women who form the single largest group of discriminated women.

Our conservative traditional attitude obstructs a proper appreciation of the beneficial role of women in the economic world. This traditional view not only glosses over the unequal deal women get but finds nothing wrong with the arrangement. The origin of discrimination and exploitation of women can be traced to the inexplicable attitude of social apathy, although, Constitution of India provides for equality between the sexes with special protection for women and children. Indians in their family life have been governed by personal and religious laws which fail to give women their due. These laws have relegated Indian women to an inferior legal as well as social status.

It is true that despite the statutory rights enjoyed by women, discrimination against them is still prevalent. Article 51-A(E) of the Indian Constitution deals with people's welfare and dignity of women, no matter how exalted a position they hold and has seldom been invoked against violations. Discrimination against women is an ancient practice and it is women's long term fight against the hardened attitude of society which needs a serious assessment of issues concerning women.

Therefore, while calling social support and providing immense employment opportunities to women, our country proposes to establish a National Resource Centre for Women so that it may play a vital role for gender issues. In fact the Indian social life requires upgradation with efforts of sensitisation, training and evaluation for greater impoverishment among women.

Under the Constitution, the President has a free hand in the appointment as well as in the dismissal of the Governor as he holds his office during the pleasure of the President. The Governor is the representative of the President in the State as an executive head.

There were instances where Governors were dismissed unceremoniously by the Central Government without any reason. Another unsavoury practice is the removal or transfer of governors with the change of government at the centre. In practice, the office of the Governor became co-terminus with the party in power at the centre, the argument that the Governors should not function in a partisan manner may lose its validity. The appointment and removal of a Governor in India have become a notorious partisan and political affair which is to be deplored. This partial politicisation is the very anti-thesis of working on consensual basis. The dignity of the office of the Governor is undermined and the Constitutional doctrine of the pleasure became nothing but a substitute for personal or partisan patronage.

The Sarkaria Commission suggested that the Governor's tenure of office of five years in a state should not be disturbed except very rarely and that too for some extremely compelling reason. The Commission did not favour the appointment of a person with strong political connections as the Governor of a State.

Today, the appointment and removal of the Governors has become a major problem in the centre-state relations. The insecurity of the term of his office can create considerable insecurity in the minds of the Governor and impair his capacity to withstand pressures, resist extraneous influences and act impartially in the discharge of his discretionary functions. The only solution for this is the amendment of the Constitution to follow the procedure of the removal of the Chief Justice of the Supreme Court in the case of removal of a Governor.

In our society half of the population consists of females. Many ladies are attending the offices, factories, shops etc. to earn their livelihood and to maintain their families. Many women workers are being sexually harassed at their work place.

The harassment against women is also called 'eve-teasing'. Such methods of insulting the modesty of a woman or outraging the modesty of a woman are offences under the

Indian Penal Code. Verbal abuse, obscene gestures and assault of the 'flasher's are not easily dealt with by law.

The law savers are not above the board. Recently, a young lawyer practising at the A.P. High Court killed herself leaving behind a suicide note, a diary and an affidavit accusing senior male colleagues of sexual harassment.

The Supreme Court has defined "sexual harassment as including such unwelcome sexually determined behaviour (whether directly or by implication) as physical contact and advances; a demand or request for sexual favours; sexually coloured remarks, showing pornography; any other unwelcome physical verbal or non-verbal conduct of sexual nature."

According to the guidelines, it is the duty of the employer or other responsible persons in workplaces or other institutions to prevent sexual harassment and to provide procedures for resolution of complaints.

Some states have passed Eve-teasing Acts. The law provides a maximum punishment of a fine of Rs. 10,000 and/or a year's imprisonment. However, eve-teasing continues to date.

Most of the women who face harassment on a daily basis prefer not to complain to the police because they are afraid of falling from the frying pan into the fire. Even in the odd instances when they do, police personnel prefer not to register cases. They go a step further and advise women to be careful and not provoke men by 'dressing indecently'.

Some suggest that women should be brave enough to face men by learning 'karate' and other martial arts. Some advise that women should move freely with co-workers as they move among their brothers and should not give scope to others to move otherwise; some say that there is no permanent remedy for this problem.
