Our unit is committed to expanding and enhancing our publication offerings to better serve the evolving needs and interests of our college community.

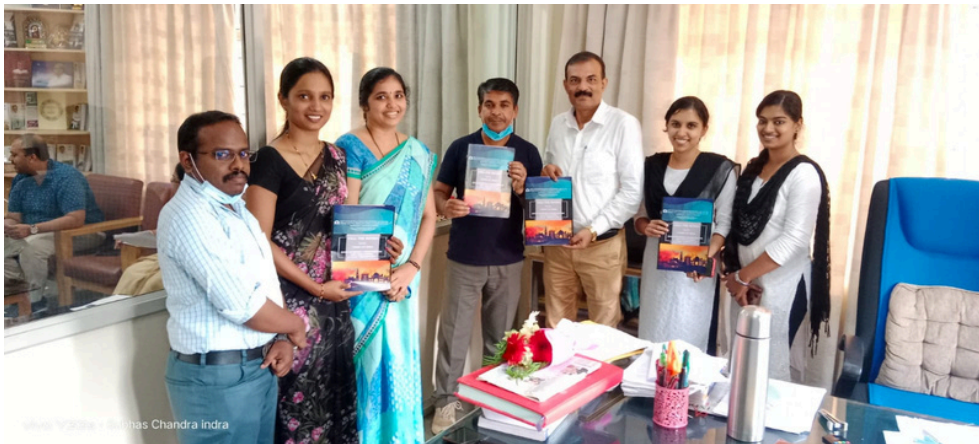
OBJECTIVES:-
