The key speakers were:

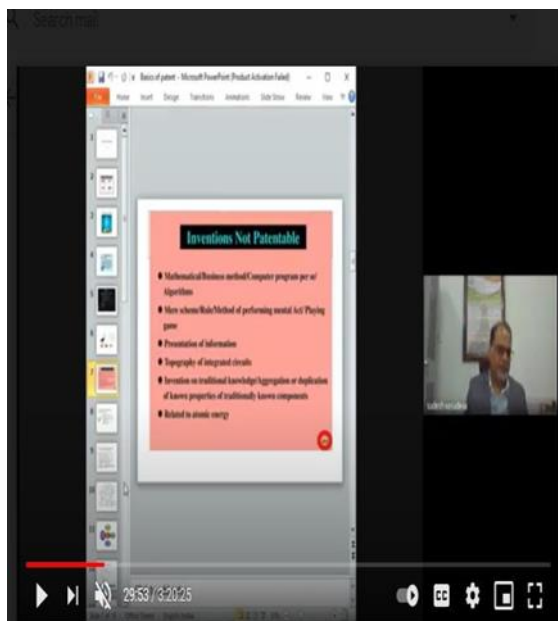
- Mr. Shanker Bhat, Advocate, Mangalore Bar Association delivered a talk on the topic "Skills of Drafting Pleadings".

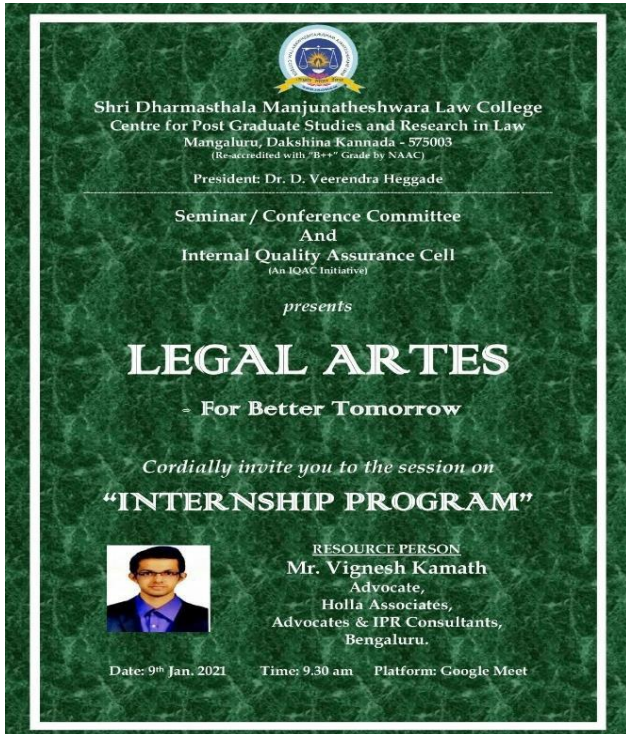
