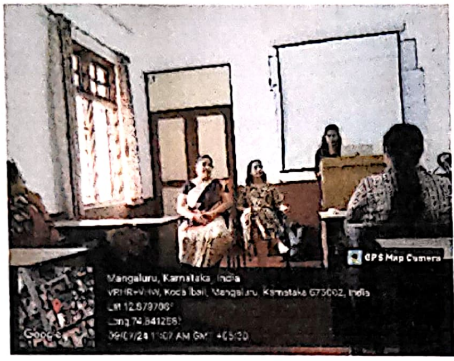

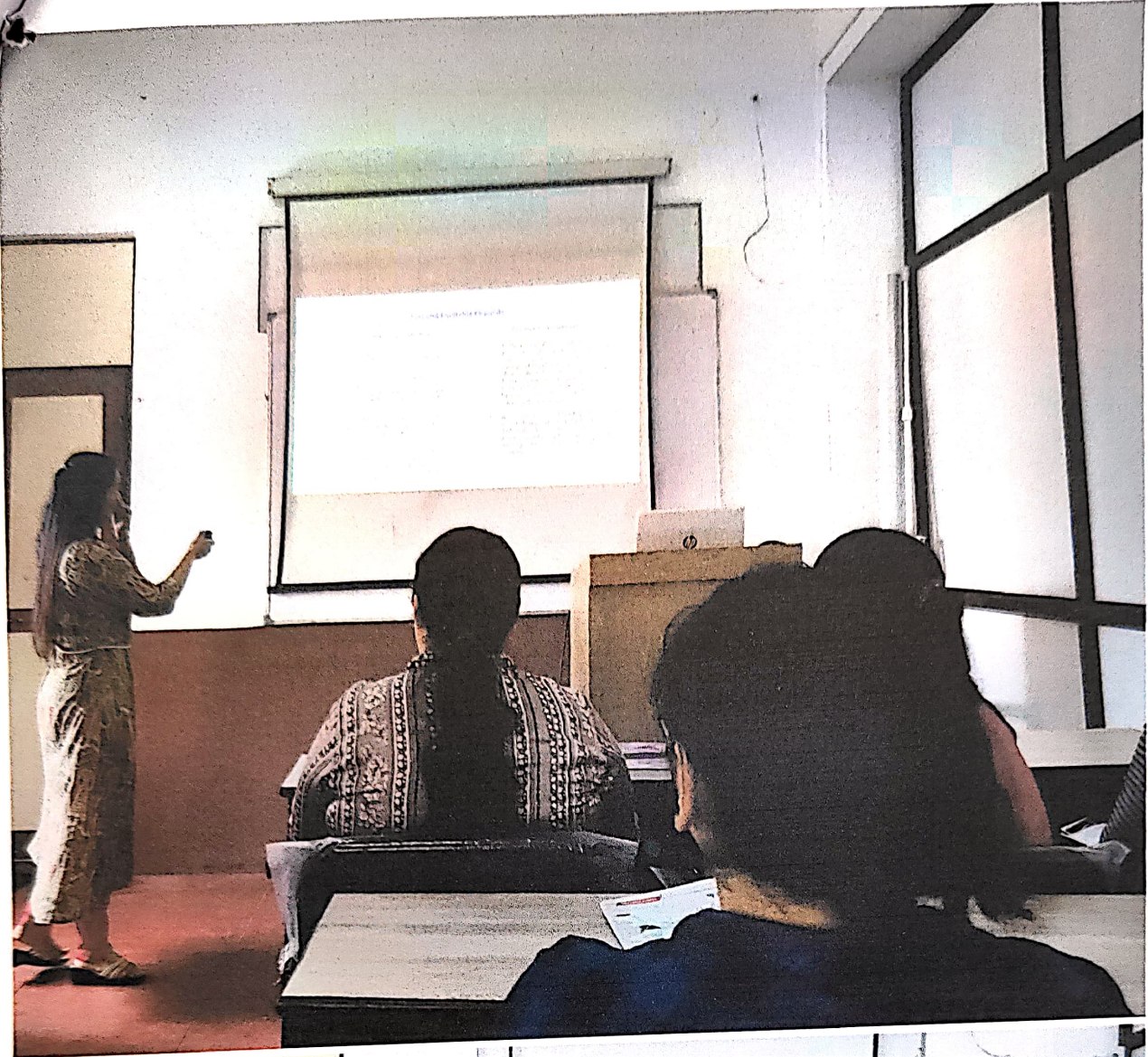
She briefed about the modes of winding up of companies and also cited several recent judgements on the aspects.
