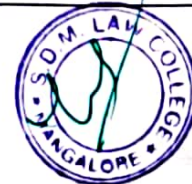

## National Webinar Report: Impact of Covid-19 on Judiciary and Legal Studies

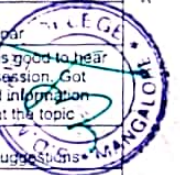

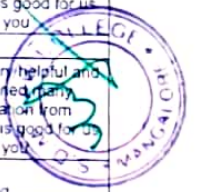
