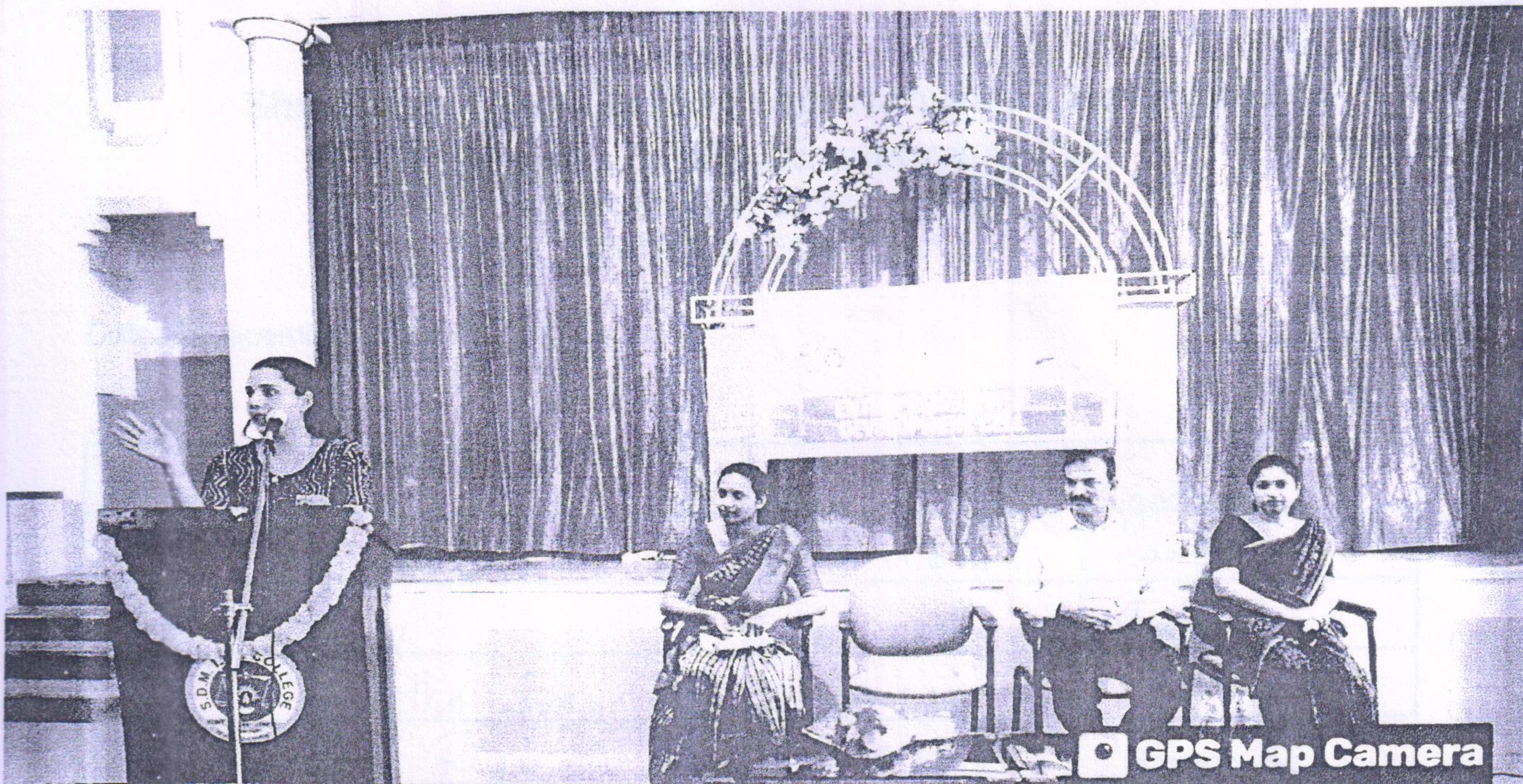

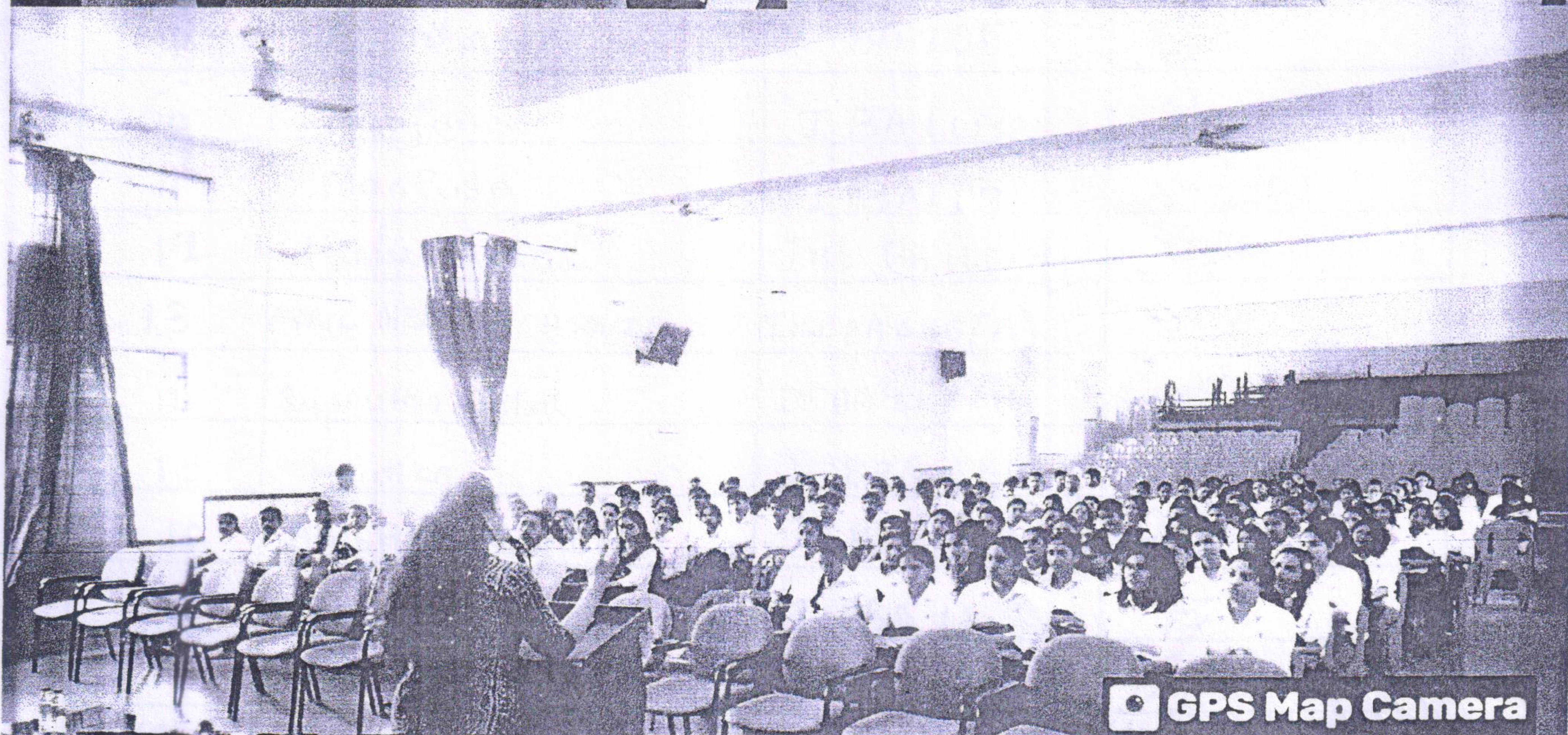


GPS Map Camera

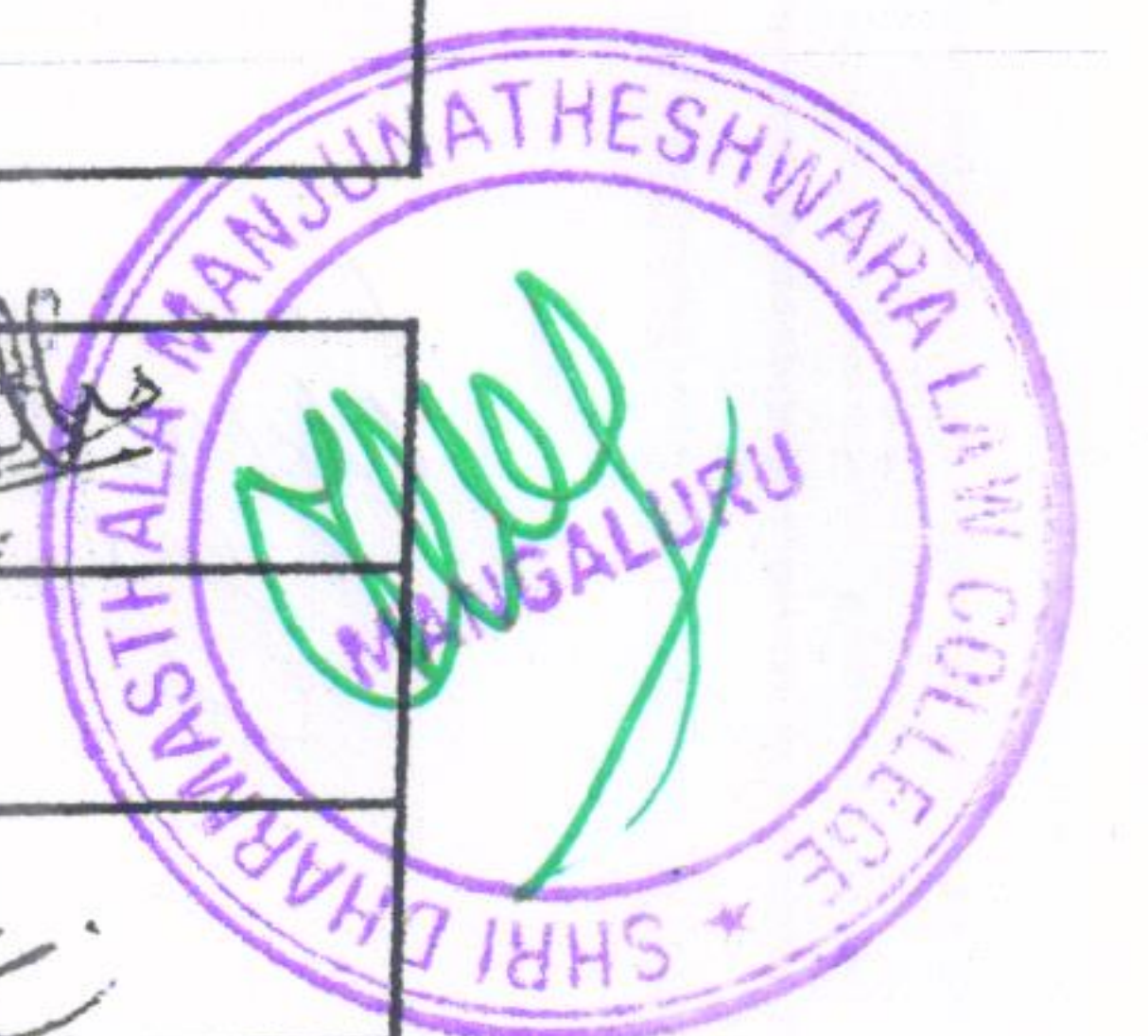


### Meeting Proceedings
