## Report

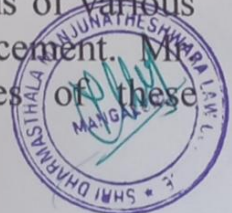
**Date and Venue:** The workshop on Customs Law was held on 23rd November 2019, Saturday, at Auditorium SDM Law College.
