


Student Feedback Analysis 2023 - 2024





The majority of students (92%) found the classroom environment conducive to learning and discussion, indicating a positive and engaging space.

Almost all students find the textbooks and course recommended materials 86% very relevant and up-to-date, while only 14% disagree.







92% percent of the students found that the course objectives and learning outcomes were achievable; thus, the syllabus was well-structured. Only 8% said that the objectives were not achievable.

Do you feel that the college provides adequate support for academic writing, research, and presentation skills?







Did you feel that the course helped you develop important skills (e.g., critical thinking, problem-solving, communication)?




The feedback indicated that an overwhelming majority 91% of the respondents believed that the course aided in the development of important skills such as critical thinking, problem-solving, and communication.






Feedback Analysis Alumni 2023 -2024





Did you find the college library to be well-stocked and well-maintained?









Did you feel that curricular and co-curricular activities helped to enhance your learning experience and personal development?




According to the alumni feedback, while most of them (54) felt that both the curricular and co-curricular programs had a positive effect on their process of learning and development, 4 of them disagreed.

Were the course materials and Syllabus up-to-date and relevant?






According to the data, 53 of the alumni responded that the course materials and syllabus are modern and relevant, which certainly denotes a strong majority of positive feedback.

Do you think that there is a need for changes to the curriculum to better prepare students for the legal profession?



according to the data, 34 out of the respondents who were alumni felt there is a need for change in the curriculum to better equip students within this legal profession, while 24 felt otherwise. This means that at least more than half of the respondents felt that there is a need for change within the curriculum.

Any other suggessions

Practical training: The alums have asserted that there is a need for practical training, which includes moot court sessions, court visits, and internships to expose the students to grassroots situations on the ground.

Curriculum Update: Alumnii suggested that there should be a regular updating of the curriculum, in keeping with the changes in laws and rules, and including new subjects and topics of relevance to the profession.

Improved job prospects: Respondents from the alumni expressed the need for more emphasis on clinical learning and internships in order to attain better job prospects.

Increasing participation in moot court: The suggestions provided by the alumni were to make participation in moot court sessions compulsory and increasing the number of sessions. Invite guest lectures: The alumni suggested that practicing advocates should be invited for guest lectures to provide an industry-institution interface for better understanding of the practical fields.

Pressure on university: The alumni called upon the university administration to undertake pressing upon the government for changing the subjects and removing repealed laws from the curriculum.





Do you regularly meet class mentor, Student Welfare Officer, Principal?








Are you happy with present syllabus?







This data suggests that 100% of parents (30/30) participate in the admission process of their ward.

Any other suggestions -

- 1. Location and Accessibility: The parents are not from Mangalore. Hence, they cannot meet the mentor frequently.
- 2. Teacher Quality and Teaching Style: Some teachers keep changing frequently; therefore, adjusting to the teaching style of these teachers is a bit tough for the students. Some teachers' accents are also not clear, which becomes difficult to follow by the students.
- 3. Teaching Methods: The parents are of the view that the college should bring in some new laws and teaching methods, like moot court, for better learning.
- 4. Facilities and Study Environment: The parents demand more facilities in the college to study in a group.
- 5. Support System: The management and faculty members are really very supportive to the holistic development of the students, which is a plus point for the institution.

In summary, the feedback from parents ranges from some points to be improved regarding the quality of teachers and teaching methodology to general appreciation for the supportive atmosphere of the college towards its students and a positive learning environment.








FACULTY FEEDBACK ANALYSIS 2023 - 2024

Are the curriculum and course materials relevant and up-to-date to educate students for legal profession?



From the feedback, 85% (12) believed that the curriculum and the material were relevant and current with regard to the legal profession, expressing much alignment with current practices, while 15% (2) see possible gaps or outdated content.

Do you find the student assessment and evaluation methods effective in measuring student learning outcomes?



While more than three quarters of the respondents see that the student assessment and evaluation processes are ways to measure student learning outcomes, a percentage of 21.4% do not. This means that the majority consider that the existing ways of assessment are in general reliable as methods of ensuring the students' course.





Do you receive adequate support and resources for teaching and curriculum development?







Are the students encouraged to participate in co-curricular activities and develop their leadership skills?









Majority of the faculty members say they can provide individualized attention and support to students when they need it, which also points toward concrete student support and outreach efforts.

Most faculty members, 13 out of 14, felt the college was offering enough professional development opportunities, and the only exception showed the negative point of view; that is, the general sense of faculty satisfaction is extremely high.

Any other Suggessions -

The feedback says the law school needs to work on teaching, technology, and facilities. It has suggested upgrading AV, increasing library space, and increasing students' practical exposure to prepare them for the profession that lies ahead.





Do you think that syllabus prescribed is both student and teacher friendly in nature?



it is analysed that Majority of the respondents opined that the prescribed syllabus is student and teacher friendly, pointing toward a very positive perception about the curriculum being approachable and effective. However, a sizable minority had reservations, suggesting some areas for reform.

Is the syllabus professional / Market oriented?



85% of the comments on the syllabus suggested that it was professionally oriented, thus showing strong relevance and practical application of industry. This is again in line with modern workforce needs, for it lays emphasis on the market-oriented education.










Out of the 58 students, 28 of them point out the drawbacks in the current syllabus, thus showing that there is much room for improvement. The major causes of dissatisfaction for students are basically based on the curriculum content that is still very outdated, scanty coverage of relevant topics, and unsatisfactory teaching methods.

Is the system of continuous evaluation is stisfactory?



For the majority of students – 39, this system of continuous assessment is quite satisfactory. In general terms, this would mean that perception is good, but it corresponds to a high percentage – 19, that does not share this opinion, which leaves some concerns or those areas for improvement in the evaluation process.

What are the teaching/learning methods needed?

The feedback received shows that the following are the most frequent methods of teaching/learning adopted:

Chalk and Talk Method — 30 times

Case Study Method — 23 times

Discussion Method — 20 times

The Socrates Method is mentioned on several occasions, but less frequent than the other two.

The analysis shows that more than one method of teaching/learning is adopted in practice. The common combinations are:

Chalk and Talk Method + Case Study Method + Discussion Method - 13 times

Chalk and Talk Method + Discussion Method (8 times)

Chalk and Talk Method + Case Study Method (6 times)

The Socrates Method is often used in combination with other methods, particularly with the Case Study Method and the Discussion Method.

The least used method is the sole use of the Discussion Method, which only appeared 3 times.

It can be analysed that, the findings suggests teachers often combine teaching/learning methods for the achievement of instructional goals. Some of the commonly used methods include the Chalk and Talk Method, the Case Study Method, and the Discussion Method, which in most cases are used in a mix with one another.

What are the changes you suggest in practical training Courses?

Suggessions -

- 1. Reduce writing tasks: Most of the students are of the opinion that the quantum of writing is too heavy and sometimes unwarranted. The simplification of writing tasks or the number of written assignments may be reduced.
- 2. Student satisfaction survey: A survey may be conducted regarding the satisfaction levels among the students about the practical training course. This will help to improve the shortcomings.
 - 3. More practical knowledge: The students want to be taught practical things related to the application of the course materials and how to apply the rules and regulations in real life.
- 4. Friendlier lecturers: The students desire to have more understanding lecturers who are friendly and accessible both in and out of class.
- 5. Do away with unnecessary work: Removal of such additional work as the requirement to keep a personal diary will save time for more critical activities.
 - Addressing student needs: The faculty should respond to the requirements and issues of students and must think from the student's perspective.
- 7. Syllabus-based teaching is necessary: The faculty should cover the syllabus and mention all the essential points for answering the questions so that students can prepare well before the examination.
- 8. Bilingual: Teaching in multiple languages, such as Kannada, may help students grasp concepts more clearly.
- 9. Real life situations: More practical examples and case studies in the practical training courses to help students comprehend how theory can be applied in practice.
- 10. Mandatory visits to courts: Make court visits mandatory for the students and encourage them to think and reflect upon their experiences.

Suggessions from students proposed 10 changes that will help better practical training courses. They are reducing writing tasks, survey on student satisfaction, providing more practical knowledge, friendly instructors, avoiding unnecessary tasks; meeting the student needs, teaching in accordance with the syllabus; instruction in multiple languages; investigation of real-world scenarios; and visiting courts compulsorily.











Current practice in courts: Include mock trials and negotiation mutes and client counseling mutes to bring into focus actual scenes.

Early Clinical Legal Education: Appropriate all-round clinical legal education in students would imply that beginning in the first year, all students are entitled to participate in clinical legal education in their locality.

Focus on academics: This is focusing on academics other than extra-curricular activities according to the respondents, which means there should be a focus on academic achievement.





The syllabus is considered professional and market-oriented. A high percentage of students, 75.7% (257 out of 341), agree that it is relevant to the industry, while only 24.7% (84 of 341) disagree, indicating a tight link between the curriculum and professional demand.




Do you think that syllabus prescribed is both student and teacher friendly in nature?

The syllabus provides class structure and lucidity but somehow does not take into account the needs and preferences of both students and teachers, hence creating an air of inefficiency and unhappiness.

The majority of students want to have a more interactive and collaborative learning experience (140 out of 341). In other words, what students want is an opportunity to share, with peers, ideas around and develop their critical aids, which in turn develops the requirement for critical thinking and skills in thinking through their practice.

The fact that the number of students relatively smaller (60 out of 341) in mention of recommending the need of the chalk and talk method may show that they may feel that it is too lenient and does not offer the necessary stimulation and consultation.

The high number of students, 141 out of the total 341, suggesting the need for the Socratic method reflects that opportunities to critique ideas are important to them.

What are the draw backs you see in the present syllabus?

Analysis -

most of them refer to practical skills and project-based learning, as well as assessment methods and feedback. It would therefore mean that students feel the syllabus is too inclined towards theoretical aspects and does not afford students with enough hands-on learning experience and practical applications.

The next most prevalent issues that appeared were the high levels of stress and unsatisfactory support for students with mental health and disability issues. This would mean students feel burdened by curriculum demands and have less-than-satisfactory support to keep their well-being in check.

Of the other deficiencies, 6 of 34 were related to a lack of emphasis on innovation, critical thinking, and soft skills development, as well as a lack of opportunities for group work and individual contributions by students. In some ways, this may be taken as suggesting that the students feel the syllabus is over-individualistic, with insufficient scope for collaboration and creativity.

In general, much of the feedback seemed to indicate a desire for more interactive and student-centered learning that would allow students to work with one another, develop ideas, and further acquire and hone their critical thinking and communication skills.














