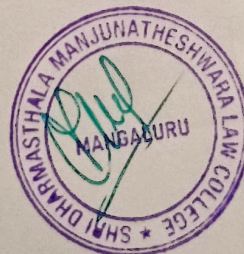
Training, Internship and Placement Cell

The Training, Internship and Placement Cell of the college, encourages students to take up internships at various avenues like reputed law firms, law associates/chambers, judicial academy, law ministry, CBI, bio-diversity boards, Patent and trademark office, NGO's, Corporate offices, compliance departments, revenue, police departments and research units. Practical training, regular chamber and court visits are arranged for students of final year.

Apart from placement activities, the cell also organises, soft skill training programme, personality development workshops, and workshops on resume writing, professional etiquette, stress and time management and related topics. To ease the selection procedure, cell also organises mock interview and shortlisting of candidates based on their interest.

In the past 5 years, top recruiters from the country, including companies, law firms and legal professionals have visited the college and successfully recruited a good number of students every year. Annual Placement Drive of the college benefits students of all colleges in and around Mangalore. Pre-placement sessions are also held to familiarise students with recruiters.
