SPECIAL INSTRUCTIONS TO THE CANDIDATES

1. Only one family member shall accompany each candidate for the oath taking ceremony.
2. Candidates who are from the Containment Zone or who had primary/secondary contact to any COVID-19 PATIENT should submit their Covid-19 Reports and other candidates shall submit self declaration that they are not from the Containment Zone or they had not primary/secondary contact with any COVID-19 PATIENT.
3. Candidates are advised to download and install the 'Arogya Setu App' (<http://play.google.com/store/apps/details?hl=en-IN&hl=en-IN>), 'Apthamitra App' and 'Quarantine Watch App' in their Mobile and also ensure that Location and Bluetooth is turned on at all the time when they are in the High Court premises.
4. The entry and exit of candidates who are attending the oath taking ceremony shall be only through Gate No.03 near High Court Post Office.
5. Candidates, with one family member only are allowed to enter the High Court premises just before the scheduled time on production of their call letters for oath taking ceremony.
6. In view of current Covid-19 situation, the candidates traveling overnight by buses, are advised to wear clean and fresh clothes in order to maintain personal hygiene.
7. Candidates entering the High Court premises are instructed to co-operate with Medical Screening team and Para Legal Volunteers.
8. Mandatory Thermal Screening of all candidates will be done while entering the High Court premises and the candidates who are found to have above normal body temperature will not be allowed to enter the premises of the High Court and the decision of Hon'ble the Chief Justice in this regard is final.
9. Candidates entering the High Court premises shall wear face mask throughout their stay in the High Court premises.



10. Candidates shall wear hand gloves while submitting their documents to this office at the time of oath taking ceremony and shall use hand sanitizer.
11. Candidates shall strictly follow social distancing norms during their stay in the premises of the High Court.
