



RULES GOVERNING CONSTITUTION AND FUNCTIONING OF COMPOSITION OF STUDENT EXECUTIVE COUNCIL

(With effect from 1st March, 2023)

- 1. There shall be one class representative elected from each class based on direct election. Any candidate standing for election shall have 70% attendance in all preceding years excluding grace attendance except for the college purposes.
- 2. The class representative so elected shall act as class representative for all other committees/cells in the college. It is his/her responsibility to communicate, involve, inform his/her class students about all activities of the college.
- 3. There shall be Secretaries/Co-ordinators for various cells/committees. Secretaries shall be selected based on interview/selection test as may be presented by the convenor of the committee/cell in consultation with the Principal.
- 4. Each committee/cell shall have one Secretary preferably from final years (priority shall in a descending order) and not more than four student co-ordinators out of which 50% shall be always women co-ordinators. The co-ordinators can be from any class.
- 5. For all posts of Secretary/Co-ordinators the attendance requirements as per Rule (1) shall be binding. If found in any stages of selection that he/she has not fulfilled the first requirement as mentioned in Rule (1) with respect to attendance his/her candidature/selection shall be summarily rejected without any hearing.
- 6. Secretary (Academics) shall be deemed to be the Chief Secretary of Students Executive Council to co-ordinate all activities of the Cell/Committees. The Secretary (Academic) shall be selected based on aggregate marks obtained in all the previous semester only of law subjects (i.e. from III year of 5 years course onwards and from first year of three years LLB course). The Secretary (Academics) Post shall be reserved only for final year students. If a highest mark holder declines the offer, the preference shall be given to the second highest mark holder irrespective of the stream. In case the first highest mark holder accepts Secretary (Academics) he/she will be automatically elevated as the Principal Secretary and the second topper from all steams shall be the Secretary (Academics). The first topper if declines to the post secretary/ the second topper shall become the Principal Secretary and the topper can continue as the Secretary (Academics). For this post also attendance requirement as mentioned in Rule (1) applicable without fail.

- 7. The Chief Secretary of Students Executive Council shall be the representatives of Student Executive Council and ex-officio member of IQAC, student representative of the Governing Council and all / or such other activities as communicated to him by the student welfare officer (hereafter SWO) or staff advisor from time to time.
- 8. The Secretaries shall act under the guidance of Faculty Convenors and they are required to be co-ordinated by the (SWO) or staff advisor from time to time. The SWO shall call periodical meeting/ad hoc meeting as and when necessary and record the proceedings of the meeting.
- 9. The Staff Advisor (SWO) shall compile list of activities and with the help of the Vice Principal plan out activities in such a manner as to avoid any conflicts / frictions in organization of any events / programmes.
- 10. The decision of SWO in consultation with the Vice Principal shall be binding. However, in exceptional situation the Principal may review the decision in the interest of the institution. No office bearer shall directly approach the Principal without exhausting alternative remedies as provided in the list of hierarchy of authorities.
- 11. The Principal has every right to alter, modify, repeal, include, exclude and all other things as may be required in the interest of the institution and as such his decision shall be final. In such circumstances no reasons are given for the decisions of the Principal.
- 12. In any case of Secretaries/co-ordinators except class representatives 50 percent of component is relating to passing of entrance test to be conducted by the college and remaining 50 percent shall be decided by the convenor which may include interview / written test / nomination as the case may be.
- 13. In cases of non-selection / non-availability of eligible class representatives
 - candidates for Secretaries and co-ordinators, Chief Secretary of Students Executive Council / Secretaries / coordinator, the Principal will nominate for such posts. Nomination shall be made by the Principal if candidate so elected / selected rejects / leaves the college / behaves in such manner derogatory to the post / unfit or any other circumstances disentitling the candidate for said post.
- 14. Notwithstanding anything contained in previous rules the Principal can nominate any foreign student / exceptional meritorious student to any committee / Cell as the Principal's representative in exceptional cases.
- 15. No office holder is allowed to claim the membership of any political / religious group inside the college campus.

CORRIGENDUM

With effect from March 1st, 2023 in rules governing the constitution and functioning of composition of Students Executive Council 2019-20 clause no.6 mentioning that the "Principal Secretary" the same shall be substituted and replaced with word CHIEF SECRETARY OF STUDENTS EXECUTIVE COUNCIL for all purposes hereafter wards.

NOTIFICATION FOR THE POST OF CLASS REPRESENTATIVES AND SECRETARIES FOR VARIOUS CELLS AND COMMITTEES OF THECOLLEGE

(Academic year 2023-24)

1. Rules relating election / selection of Class Representatives

- There shall be one class representative for each class on the basis of direct election / selection.
- Any candidate standing for elections shall have 70% attendance in previous semester
- Any class representative so elected or selected shall be the class representative for 1 academic year 2023-24.
- There shall not be any scope for resignation for the post of class representative.
- Class representative shall not be the secretary or coordinator of any committee / cells.
- In case of results of election where two candidates secure equal votes in that case both candidates will be class representative on rotation basis for each of the semester.

2. Chief Secretary

- Final year students of all streams are eligible for the post of Chief Secretary provided that he/she shall have 70% attendance in previous semester.
- The Chief Secretary shall be selected on the basis of aggregate marks in the University Examination and also marks obtained by them in the selection test (entrance test) followed by oral interview.
- Since most of original marks cards of previous semester are not received by the students and college, the students who cleared all papers of all previous semesters in the first attempt are only eligible for the post of Chief Secretary. However applicants are required to attach internet copy of their results of all previous semesters (1st attempt result only) along with application.

Any student applying for the post of Chief Secretary is not eligible for the post of Secretaries of other committee/cell.



3. Secretaries

- All final year students are eligible for the post of secretaries provided that he/she shall have 70% of attendance in the previous semester.
- Secretaries posts shall be filled up only through written examination and oral interview.
- Students while applying for the post of Secretaries can apply for 3 committee/Cells based on their preference. But a student can be secretary for only one cell/committee.

Mode of Selection

- The examination for the post of Chief Secretary and all other Secretaries will be conducted together.
- Written examination will be conducted on the dates mentioned in the annexure provided in the notification.
- Written examination shall contain 30 MCQS carrying one mark each which will dealt with leadership qualities, general knowledge, legal reasoning, about the college and Management information etc.
- There will not be any negative marks.
- Any candidates obtaining less than 40% in written examination will be automatically eliminated and there shall be no appeal.
- In case no candidate gets more than (12 Marks) 40% or if for any Cell or committee no student apply, then the Principal may nominate from the candidates appeared for the examination or any other student as the Secretary.
- After the written examination the eligible candidates need to appear for oral interview before the panel.

4. Co-ordinators

- The co-ordinators for various committees/cells shall be selected by the faculty Convenor of each cell/committee.
- The post of co-ordinator is open for all students of SDM Law College provided they shall have 70% attendance in previous academic year.



General Rules

- The selection process for the above post is done in accordance with rules governing the constitution and functioning of student executive council.
- Any candidate should not have violated any rules and regulations as given in the college calendar and also any rules laid down by the college from time to time.
- Canvassing in any form or bringing pressure upon students or teachers is strictly prohibited.
- Incomplete or defective applications shall be summarily be rejected.
- Students not appearing for examination shall not be considered for any post under any circumstances.
- It is the sole responsibility of the students to appear for examination on scheduled date. Health or any reason college will not result any retest for the same.
- Merit list will be displayed in the Notice Board.
- Student Welfare Officer will be chief Election Officer for all examination process.
- The decision of the Principal will be final and not appealable.
- Any clarification meet the Student Welfare Officer Dr.Chandralekha.

MINIMUM REQUIRMENTS

- 1. The eligible candidates for the post of secretaries shall not put in less than 70% attendance in the immediate preceding semester.
- 2. Any class student who is already elected as the class representative shall not apply for any post of secretaries. There shall not be any scope for resignation for the post of class representative.

- 3. He or she should not have violated any rules and regulations as given in the college calendar and also any rules laid down by the college from time to time.
- 4. Post of Principal Secretary shall be filled up only after the announcement of revaluation results of preceding semesters.
- 5. For the post of Principal Secretary a separate examination shall be conducted on specified date by the college.

MODE OF SELECTION

- 1. All Secretary Posts, except Principal Secretary, shall be filled up only through written examination to be conducted on 12/01/2023. The post of Principal Secretary is also to be filled up by written examination upon issue of notification for the same,
- 2. Written examination shall contain 50 MCQS carrying one mark each which will deal with leadership qualities, general knowledge, legal reasoning, college and management information etc. There will not be any negative marks.
- 3. Any candidates obtaining less than 35 % in written examination will be automatically eliminated and there shall be no appeal.
- 4. Answer to MCQ questions should be answered with one option legibly without any discrepancy.
- 5. Candidate less than 35% shall be automatically eliminated and in case no candidate gets more than 35% the principal may nominate from the candidates appeared for the examination or any other student as the secretary.
- 6. All final year students are only eligible for the post of principal secretary on the basis of aggregate marks in the University examination and also marks obtained by them in the selection test as and when it is conducted.
- 7. Students can apply for only one post of secretary of any cell/committee. At no point of time student are allowed to apply for more than one post.

- 8. In any case if two or three candidates get equal marks at that point of time senior class will be preferred over the junior classes.
- 9. While applying for the post of Secretary the candidate clearly & specifically has to mention for which post he/she is applying. One should specifically apply for one post of Secretary only.
- 10. If any student of final year only has been selected as Secretary of any Cell/Committee shall not resign for the post in order to stand for the selection of the Principal Secretary.
- 11. Selected candidate as per the Merit denies, resigns or fails to perform assigned duty as directed by faculty convener of the respective Committees or Cell, Principal shall nominate or notify the name of the candidate for such position or post.
- 12. Any dispute relating to selection shall be referred to an independent body headed by SWO and the principal.

GENERAL INSTRUCTIONS

- 1. Canvassing in any form or bringing pressure upon students or teachers is strictly prohibited.
- 2. Incomplete or defective applications shall be summarily be rejected.
- 3. Students not appearing for examination shall not be considered for any post under any circumstances.
- 4. It is the sole responsibility of the students to appear for examination on scheduled date. Health or any reason college will not conduct any retest for same.
- 5. Merit list will be displayed in the Notice Board.
- 6. Student welfare officer will be chief Election Officer for all examination process.
- 7. The decision of the principal will be final and not appealable.
- 8. Applications to be collected from Student Welfare Officer.

RULES GOVERNING CONSTITUTION AND FUNCTIONING OF COMPOSITION OF STUDENT EXECUTIVE COUNCIL 2019-20

- 1. There shall be one class representative elected from each class on the basis of direct election. Any candidate standing for election shall have 70% attendance in all preceding years excluding grace attendance except for the college purposes.
- 2. The class representative so elected shall act as class representative for all other committees/cells in the college. It is his/her responsibility to communicate, involve, inform his/her class students about all activities of the college.
- 3. There shall be Secretaries /co-ordinators for various cells/committees. Secretaries shall be selected on the basis of interview/selection test as may be presented by the convenor of the committee/cell in consultation with the Principal.
- 4. Each committee/cell shall have one Secretary preferably from final years (priority shall in a descending order) and not more than four student co-ordinators out of which 50-% shall be always women co-ordinators. The co-ordinators can be from any classes.
- 5. For all posts of Secretary/Co-ordinators the attendance requirements as per Rule (1) shall be binding. If found in any stages of selection that he/she has not fulfilled the first requirement as mentioned in Rule(1) with respect to attendance his/her candidature/selection shall be summarily rejected without any hearing.
- 6. Secretary (Academics) shall be deemed to be the Principal secretary to coordinate all activities of the Cell/Committees. The Secretary (Academic) shall be selected on the basis of aggregate marks obtained in all the previous semester only of law subjects (i.e from III year of 5 years course onwards and from first year of three years LLB course). The Secretary Academics Post shall be reserved only for final year students. If a highest mark holder declines the offer, the preference shall be given to the second highest mark holder irrespective of stream. In case the first highest mark holder accepts secretary (academics) he/she will be automatically elevated as the Principal Secretary and the second topper from all steams shall be the Secretary (Academics). The first topper if declines to the post secretary/ the second topper shall become the principal secretary and the topper can continue as the Secretary (academics). For this post also attendance requirement as mentioned in Rule (1) applicable without fail.

- 7. The Principal Secretary shall be the representatives of student Executive Council and ex-officio member of IQAC, student representative of the Governing Council and all / or such other activities as communicated to him by the student welfare officer (hereafter SWO) or staff advisor from time to time.
- 8. The Secretaries shall act under the guidance of Faculty Convenors and they are required to be co-ordinated by the (SWO) or staff advisor from time to time. The SWO shall call periodical meeting/adhoc meeting as and when necessary and record the proceedings of the meeting.
- 9. The staff Advisor (SWO) shall compile list of activities and with the help of the Vice Principal and shall plan out activities in such a manner as to avoid any conflicts/frictions in organization of any events/programmes.
- 10. The decision of SWO in consultation with the Vice Principal shall be binding. However in exceptional situation the Principal may review the decision in the interest of the institution. No office bearer shall directly approach the Principal without exhausting alternative remedies as provided in the list of hierarchy of
- 11. The Principal has every right to alter, modify repeal, include, exclude and all other things as may be required in the interest of the institution and as such his decision shall be final. In such circumstances no reasons are given for the decisions of the Principal.
- 12. In any care of Secretaries/co-ordinators except class representatives 50 percent of component is relating to passing of entrance test to be conducted by the college and remaining 50 percent shall be decided by the convenor which may include interview / written test / nomination as the case may be.
- 13. In cases of non selection / non availability of eligible class representatives / candidates for Secretaries and co-ordinators, Principal Secretary/Secretaries/coordinator, the Principal will nominate for such posts. Nomination shall be made rejects/leaves the by the Principal if candidate so elected/selected college/behaves in such manner derogatory to the post / unfit or any other circumstances disentitling the candidate for said post.
- 14. Notwithstanding anything contained in previous rules the principal can nominate any foreign student / exceptional meritorious student to any committee / Cell as the Principal's representative in exceptional cases.
- 15. No office holder is allowed to claim the membership of any political /religious group inside the college campus.
