Sub: Extension of approval of affiliation to Shri Dharmasthala Manjunathehvara, Law College & Centre for Post Graduate Studies in Law, Mangalore, Karnataka for imparting three year LLB with an intake of one section of 60 students, five year BA LLB with an intake of two section of 60 students in each course for a period of three year from 2015-16 to 2017-18 and also fresh approval of affiliation for five year BBA LLB law courses with an intake of one section of 60 students for the academic year 2016-17.

Sir,

Legal Education Committee at its meeting held on 22nd October, 2016 considered the inspection report of Shri Dharmasthala Manjunathehvara Law College & Centre for Post Graduate Studies In Law, Mangalore, Karnataka. After consideration, Committee made the following recommendations:

The Committee considered the inspection report of Shri Dharmasthala Manjunathehvara Law College & Centre for Post Graduate Studies In Law, Mangalore, Karnataka submitted by the inspection team. After consideration, Committee is of the view that the college didn't provide the details about affiliation of University. So the matter is deferred. Office to fax to the said college to seek the said details like whether they are continuing old course and have new course also. Whether any affiliation order has been passed by the university.

The details of faculty members including what subjects they are teaching both in law and social science which have not been mentioned. College is to send details through fax for its consideration in the next meeting.

Thereafter, the Committee again considered the compliance report submitted by the College after consideration the Committee decision as follow:-

The Committee considered the inspection report submitted by the inspection team of the Bar Council of India. After consideration, the Committee is of the view that Shri Dharmasthala Manjunathehwar Law College & Centre for Post Graduate Studies in Law, Mangalore, Karnataka be granted further extension of approval of affiliation in respect of three year LLB course with intake of one section of 60 students and 5 year BA LLB course with intake of two sections of 60 students in each section for a period of three year from 2015-16, 2016-17 and 2017-18 and fresh approval of affiliation for imparting five year BBA LLB with an intake of one section of 60 students for a period of one year i.e for the academic year 2016-17 subject to the following conditions:

Further, there is no common room for boys, it should be constructed within three months with intimation to the Bar Council of India within the same period.

So far social science faculties for five year BBA.LLB course is concerned, the college has shown two faculty members at serial numbers 7 & 8. Their qualification has not been mentioned. College is to send their qualification with term of appointment within six weeks.

1. The teaching staff has to undergo continuing education and update their knowledge and improve their teaching techniques/skills.
2. The college must strictly enforce 70% attendance as per Bar Council of India rules.
3. The college management is directed to establish the Legal Aid Centre as per Clause-11, Schedule-III of Rule-11 of the Part-IV of the Legal Education Rules - 2008.
4. College should ensure the payment of salary to teachers as per Rules 22 schedule III, Part IV of BCI Rules.
5. The institution is directed to upgrade the library as mentioned below :-

"Today with the increasing cost of journals, books, wi-fi, e-library and online facilities including I.T. facilities, the minimum investment by each university should be Rs. 10 lakhs for each year. However any university/deemed university in rural area, it should be Rs. 5 Lakh and for all other affiliated colleges in the urban area it should be Rs. 2 lakhs and in rural area Rs. 1 lakh."

6. The institution is also directed to upgrade the library by subscribing 10 sets of Indian Bar Review, selected judgments and professional Ethics published by Bar Council of India Trust.

7. Teacher Student ratio shall be as per Schedule-III, Rule-11, Clause-17, Part-IV of Bar Council of India Rules.
8. College Management should establish a computer lab for the development of Law students.
9. College is directed to inform the timings of the classes

Further, the college must specify the timing of the college which has not been given. College should also maintain the timing which has to be minimum 5 ½ hours with half an hour break. College to file an affidavit to the Bar Council of India within six weeks mentioning the timing of the classes. The relevant rules are quoted hereunder :-

Rule (xociii), Chapter I

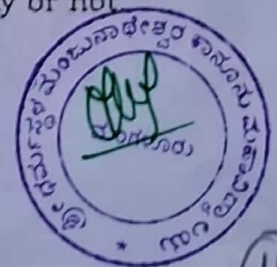
“(xociii) “Regular Course of Study” means and includes a course which runs for at least five hours a day continuously with an additional half an hour recess every day and running not less than thirty hours of working schedule per week.”

Rule 5 of Schedule III

“Classes may be conducted between 8 a.m. to 7 p.m. in an Centre of Legal Education, which is not fully residential. However the Library may remain open till 10 p.m.”

Minimum Library requirement: To start with, a Law Library shall have a set of AIR manual, Combo offer of CD of AIR Pvt. Ltd. (containing electronic version of AIR Supreme Court and High Court Data bases Research 1950-2015 (four connections each) Cr. L.J. Data Base 1950-2015 (four connections) AIR Privy Council Data Base 1900-1950 (four connections) AIR Mannual latest 6th Edition (1-45 Vols.) AIR Journal 2015, Cr. L.J. 2015, L.I.C. 2015, AIR Civil Cases 2015, AIR Law Lines 2015, AIR Cheque Dishonour Reports 2015, AIR Accident Claims and compensation 2015, Institution shall get electronic versions updated every year by AIR Pvt. Ltd. Central Acts and Local Acts, Criminal law journal, SCC, Company cases, Indian Bar Review, selected Judgements on Professional Ethics and Journals with the back volumes for at least ten years and also such number of text books in each subjects taught during the period according to the minimum standard ratio of ten books for each registered students. For running integrated program, text books of such other subjects are also to be kept in the similar minimum ratio.

Further, the institution should follow the attendance rule and file reply that they are going to follow the aforesaid rule. The next inspection team must see whether the said rule is being followed by the university or not. The relevant Rule 12 is given below :-



"12. End Semester Test: No student of any of the degree program shall be allowed to take the end semester test in a subject if the student concerned has not attended minimum of 70% of the classes held in the subject concerned as also the moot court room exercises, tutorials and practical training conducted in the subject taken together.

Provided that if a student for any exceptional reasons fail to attend 70% of the classes held in any subject, the Dean of the University or the Principal of the Centre of Legal Education , as the case may be, may allow the student to take the test if the student concerned attended at least 65% of the classes held in the subject concerned and attended 70% of classes in all the subjects taken together. The similar power shall rest with the Vice Chancellor or Director of a National Law University, or his authorized representative in the absence of the Dean of Law.

Provided further that a list of such students allowed to take the test with reasons recorded be forwarded to the Bar Council of India."

College should also admit students as per the below mentioned Rule:

7. Minimum marks in qualifying examination for admission: Bar Council of India may from time to time, stipulate the minimum percentage of marks not below 45% of the total marks in case of general category applicants, 42% for OBC category and 40% of the total marks in case of SC and ST applicants, to be obtained for the qualifying examination, such as +2 Examination in case of Integrated Five Years' course or Degree course in any discipline for Three years' LL.B. course, for the purpose of applying for and getting admitted into a Law Degree Program of any recognized University in either of the streams.

Provided that such a minimum qualifying marks shall not automatically entitle a person to get admission into an institution but only shall entitle the person concerned to fulfill other institutional criteria notified by the institution concerned or by the government concerned from time to time to apply for admission.

Institution should submit affidavit in compliance to the above conditions within six weeks.

The above recommendations were considered by the Bar Council of India at its meeting held on 13th November, 2016 and accepted the same.

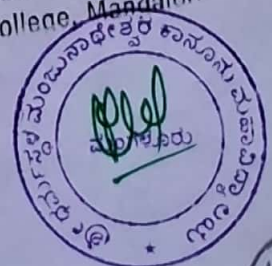

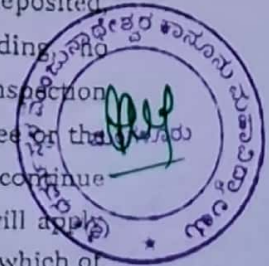

Sir,

This is with reference to above mentioned subject regarding extension of provisional approval of affiliation Shri Dharmasthala Manjunathehvara Law College & Centre for Post Graduate Studies in Law, Mangalore Karnataka which has already applied for extension of approval of affiliation for the academic year 2017-18 and inspection of the Bar Council of India is pending.

The matter relating to colleges similarly placed were considered by the Legal Education Committee of Bar Council of India at its meeting held on 30.4.2017 which was further ratified/confirmed by the General Council of Bar Council of India on 5th May, 2017. The resolution passed was as follows:

"RESOLVED that colleges whose inspection fee has been deposited application for extension of approval of affiliation is pending, inspection could be done or the inspection has been done, but inspection report could not be placed before the Legal Education Committee or the Standing Committee for its consideration, then such colleges may continue to admit students only for the academic year 2017-2018. This will apply only in case where affiliation has been granted by the University which of course shall be subject to the inspection to be made by the Bar Council of India subsequently."

I. GENERAL INSTRUCTIONS

- i) As the proud faculty of SDM institution, we need to show our utmost respect regards and reverence to all members of the management.
- ii) Faculty is entitled for OOD's in a semester to attend BOE/BOS, revaluation. Valuation of KSLU will be considered as OOD / Special leave depending upon the number of days of evaluation. Evaluation work of outside the University shall be considered as CL.
- iii) Reporting 5 minutes before the commencement of the college hour and entry in Bio-metric details shall be compulsory.
- iv) Many teachers availing leave simultaneously shall be avoided. Where faculties apply for leave only first three leave applications will be considered.
- v) Only 2 faculties are allowed to avail RH at a time on the basis of first come & first preference rule.
- vi) Writing any note on Principal's circular amount for challenging the authority of the Principal.
- vii) Movement register shall be entered irrespective of whether the teacher have informed HOI or not. Movement is only a benefit and not a matter of right.
- viii) Whenever there are any college programmes all teachers have to attend the programme unless there are classes.
- ix) When you enter the chamber never bring the students together for discussion. There are many issues on which we can't give promises/assurance to the students. If you need the student's presence prior intimation to the Principal is a must.
- x) When the Principal is on leave VP is incharge or in his/her absence the next senior faculty will be incharge. You need to get their permission / inform her / him about your movement / programmes and such person in charge only can preside over college related events.
- xi) Never do class adjustment / combined class / leave the classes without the permission of concerned authority. For class adjustment there will be a separate teacher in charge and for others you need to get the permission of the Principal.
- xii) Promote brotherhood, fraternity and amicable relations amongst students.
- xiii) Class room experience can be enhanced by activities. However conducting activities which results in non-completion of syllabus is not at all permitted.
- xiv) Hierarchy to be followed respectfully. Senior teachers to be treated with respect by other teachers in next cadre.
- xv) If you want to attend any programme, please don't request for exchange of classes or adjustment of classes and leave the college. Instead you can avail a half day C.L depending upon your appointment rules.
- xvi) All are working as employees of this college and doing our official work. Please don't bring your personal problems for any concession or special treatment.

II ACADEMIC

1. VICE PRINCIPAL

- 3) To represent the institution in the absence of the Principal.
- 4) Assistant Information Officer of the college.

2. HOD'S LAW /HUMANITIES:

- 1) HOD's shall be appointed from the cadre of senior teachers (i.e. teachers with more than 10 years experience in Law and Humanities) on rotation basis for a period of one year.
- 2) HOD's shall be overall incharge of academic administration of college.
- 3) Formulation of IA Time Table, Practical Training Time Table, Practical Training Viva Voce in consultation with the staff advisor.
- 4) Summoning students with the attendance shortage & giving appropriate instructions.
- 5) Adherence to Uniform regulations & taking appropriate actions in case of uniform deviations.
- 6) Attending stage programmes relating to academic activities.
- 7) Instructions to the concerned teachers for submission of Attendance Track record after getting opinion from the Staff Advisor.

3. STAFF ADVISOR:

He/She shall represent the interest of teachers during the academic year of his / her assignment as the Staff Advisor.

1. Setting of internal exam time table / practical training schedule in consultation with HOD's.
2. Monthly and quarterly report to the management.
3. Recording, Maintenance of staff meeting proceedings.
4. Staff grievance with respect to infrastructural problems.
5. Coordination of attendance track record.
6. Monitoring of events by various cells / committees in consultation with SWO collecting the dates of activities and to see that collusion shall not take place and as far as possible classes are not compromised due to activities.
7. Collecting advance information on staff leave and making alternative arrangements and informing staff in charge of time table adjustments.
8. In case of staff advisor on leave the student welfare officer shall be the acting staff advisor and shall discharge such responsibilities as expected from the staff Advisor & Vice-versa.
