Best Practice I: Awareness of Fundamental Duties and General Laws: An Extension Activity

- 1. Objectives:** The Legal Aid Cell of the college launched a program aimed at educating and developing school children's minds to become responsible and conscientious citizens in the future.
- 2. The Context:** In a time where rights are frequently asserted, it's crucial to cultivate awareness of our fundamental duties and other laws. Promoting this awareness is essential to cultivating responsible citizens who possess admirable qualities and can make meaningful contributions to a progressive and accountable society.
- 3. The Practice:** The Legal Aid Cell of the college screens and trains responsible and determined students who are then dispatched to different schools to promote awareness about fundamental duties and other laws like cyber laws, Traffic laws, POCSO etc and shape them into responsible citizens.
- 4. Evidence of Success:** The student volunteers who were chosen, have visited various schools, raised awareness about fundamental duties and other laws, and ignited a passion for them among the children. As a result, they have achieved their objective.
- 5. Problems Encountered:** The primary challenge faced by students was the language barrier. In rural schools, the medium of instruction was the regional language, causing communication problems for student volunteers who were not fluent in it. Similarly, students from different states interested in volunteering faced difficulties due to their lack of knowledge or fluency in the local languages.
- 6. Outcome:** Student volunteers covered various schools in and around Dakshina Karnataka, Kasargod, Kerala and effectively raised awareness about the fundamental duties and various laws and acts enshrined in the Indian Law, imparting its values

One can avail the service from them totally free of cost.” Cases hearing in the court may take a lot of time, instead one can take alternative resolution in Lok Adalat. Court like step-up will be arranged. Cases are solved within one to two sitting. Best Practice II: Alternative Dispute Resolution Centre

- 1. Objectives:** To support and advance Alternative Dispute Resolution (ADR), reflecting the core values of our parent institution.
- 2. The Context:** The adage "justice delayed is justice denied" emphasizes the urgency for effective dispute resolution. With courts increasingly burdened by litigation, there is a growing need to explore alternative methods. Recognizing this, our institution established the ADR Centre to offer a cost-effective and accessible solution. The centre not only serves the community by providing alternative dispute resolution services but also exposes students to arbitration and mediation techniques.
- 3. The Practice:** The ADR Centre handles cases referred by the courts for arbitration, as well as disputes where parties voluntarily choose our centre for resolution. The centre provides essential resources, including venue and administrative support, to facilitate these proceedings.
- 4. Evidence of Success:** The institution's ADR Centre has become a preferred venue for arbitrators, who frequently utilize its services for conducting arbitration proceedings. By offering affordable resources, the ADR Centre has significantly reduced the financial burden on disputing parties, making ADR more accessible.
- 5. Problems Encountered:** Initially, the centre faced challenges due to underdeveloped infrastructure and resistance from those accustomed to the traditional court-based dispute resolution system. However, these obstacles were gradually overcome. With the increasing number of parties approaching the centre, there has arisen a need to expand the centre. There is a growing demand for online ADR facilities, which requires the development of suitable online infrastructure to meet this need effectively.
- 6. Outcome:** The ADR Centre has successfully established itself as a trusted and effective platform for resolving disputes, leading to an increase in the number of cases being referred by courts and voluntarily brought by parties. This has not only alleviated the burden on the traditional court system but has also provided a valuable learning experience for students, contributing to their practical understanding of arbitration and mediation process. Additionally, the affordability and accessibility of the ADR Centre have made it a preferred choice for many, furthering the institution's mission to serve the community. Moreover, our ADR centre is as a viable choice for the Courts when they refer matters to Arbitration.

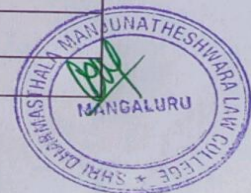

SDM Law College mediation centre most sought by lawyers

Mangaluru: The arbitration and mediation Centre established at Shri Dharmasthala Manjunatheshwara (SDM) Law College has become a hit among corporates and advocates, who have successfully settled several disputes through alternate dispute resolution like arbitration, mediation, conciliation and negotiation.

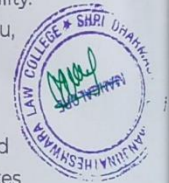
The centre started operation in 2017 and started receiving cases in 2019. So far it has closed six out of 21 cases. The hearing of each case takes place once every six months.

"Though other stakeholders in the district had started a similar initiative of an arbitration and mediation centre, it did not garner good response due to various reasons. The one that we set up at our institution received a positive response because it is situated in a law college. It has easy accessibility within city limits and has parking facility. Also, library facility is also available for reference," shared Tharanath, principal of SDM Law College, Mangaluru, adding that the facility also resembles the Shree Kshetra Dharmasthala's 'Hoyulu' system.

Retired judge Moosa Kunhi Nayarmoolle, who is also the former acting chairman of the Karnataka State Administrative Tribunal, heads the centre and settles the cases. Tharanath said, "Most of the cases are settled within two to three sittings. The maximum time taken to settle a case is six to seven sittings. Each sitting takes place every six months," he added.

The centre charges Rs 1,250 from each party for every sitting, and the institution provides staff, refreshments, a venue, and any other assistance. Tharanath shared that so far, the centre has earned a revenue of Rs 8.5 lakh. The college has plans to further enhance the facility by going online for arbitration and mediation. "It is in the pipeline," Tharanath added.

Apart from being a venue for conducting arbitration proceedings, the centre also conducts training programmes in alternative dispute resolution techniques. Trainers from the Bengaluru Mediation Centre and well-trained arbitrators from the industry train the candidates who enrol for the same.
