A} The HEI has made feedback analysis available on their webpage, accessible via the following link: (<https://sdmlc.ac.in/wp-content/uploads/2024/09/1.4.1-Analysis-doc-format.pdf>). However, the sample feedback forms are not available. Furthermore, during a review of HEI's website, DVV found no functional link for stakeholders to register complaints, feedback, or suggestions. Additional investigation revealed that while the site contains minutes of meetings and other documents, it lacks email addresses for HEI office bearers. This observation has jeopardized HEI's claim at implementing E-governance vis-à-vis Students supports at metric 6.2.3 and metric 5.1.4.

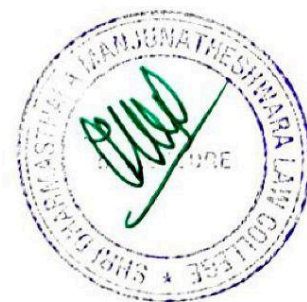
