DVV Queries for 2.1.1

A> HEI is strongly advised to complete the Excel data templates in strict accordance with the prescribed format available on the NAAC website and resubmit the Excel sheet once again. Furthermore, the seats allocated for each reserved category, along with the corresponding admitted students, must be entered separately in a column-wise manner as per the prescribed format.

B> In an affiliation notification dated 03/06/2015, HEI was granted a total of 180 seats for the five-year B.A. LL.B. and three-year LL.B. programs. Subsequently, on 24/05/2019, HEI became subject to another notification, granting the renewal of 15 intake seats for the LL.M. course. This letter also references the 60 seats for the five-year B.A. LL.B. program, which the DVV does not fully understand. HEI is requested to specifically clarify whether these 60 seats are in addition to the previously sanctioned 120 seats. Kindly provide clarification on this matter along with the necessary documents.

DVV Clarification for 2.1.1

- A) The seats allocated for each reserved category along with the corresponding admitted students is entered separately in a column-wise manner as per the prescribed format and resubmitted herewith.
- B) In the affiliation notification dated 03/06/2015 total 180 seats were granted for five-year B.A. LL.B. and three-year LL.B. On 24/05/2019 another notification was issued by granting 15 intake seats for LLM and 60 seats for B.B.A LL.B. and NOT for B.A. LL.B.


