2.1 Number of full time teachers year wise during the last five years.

A> HEI is strongly advised to fill up the Excel data templates in accordance with the prescribed format given at NAAC website, and re-submit the Excel sheet afresh once again.

Clarification: The HEI has followed the excel data template in the prescribed format on NAAC website for Law Colleges and re submitted the excel once again.

For the Academic 2021-22 we have provided 27 teachers as full time teachers and DVV shows it as 25. However we are submitting a fresh list of all 27 teachers who have served more than 300 days as full time teachers. This is in view of late commencement of academic year (November-2021) and ending at September 2022. Therefore unlike other Universities which commences in the month of June, our academic calendar is delayed, so also appointment and total working days.
