



## **ELIGIBILITY CRITERIA FOR ADMISSION**

#### BA., LLB / BBA, LL.B 5 YEARS (INTEGRATED DEGREE)

- (a) An applicant who has completed a Pre-University course or Senior Secondary School course (\*4-2') or equivalent such as (11+1,' A'level in Senior School Leaving Certificate Course)
- (b) Minimum percentage of marks in qualifying examination shall not be below 45% (44.5% and above shall be treated as 45%) of total marks in case of General category applicants, 42% (41.5% and above shall be treated as 42%) for OBC category and 40% (39.5% and above shall be treated as 40%) of total marks in case of SC and ST applicants,
- (c) Maximum age for seeking admission is limited to 20 years in the case of the General Category of applicants and to 22 years in the case of applicants from SC, ST, and other Backward communities.

#### THREE-YEAR LL.B. DEGREE PROGRAMME:

- (a) An applicant who has graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State Legislature or an equivalent national institution recognized as a Deemed to be University or foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for a three-year degree course in law leading to the conferment of LL.B. degree on successful completion of the regular program-conducted under these Regulations.
- (b) Minimum percentage of marks in qualifying examination shall not be below 45% (44.5% and above shall be treated as 45%) of total marks in case of General category applicants, 42% (41.5% and above shall be treated as 42%) for OBC category and 40% (39.5% and above shall be treated as 40%) of total marks in case of SC and ST applicants.
- (c) Maximum age for seeking admission is limited to thirty years in the case of the general category of applicants and to thirty-five years in the case of applicants from SC, ST, and other backward communities.

#### TWO-YEAR LLM IN BUSINESS AND TRADE LAWS

- (a) An applicant who has graduated in law from a University established by an Act of Parliament or by a state legislature or an equivalent national institution recognized as a deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for LLM degree course.
- (b) Minimum percentage of marks in qualifying examination shall not be below 45% of total marks in the case of general category applicants and 40% of total marks in the case of SC and ST applicants.
- (c) Govt. policy of reservation as applicable from time to time.

#### FUNDAMENTAL RULES WITH REGARD TO PLEADINGS

Pleadings are statements of facts in writings, drawn up and filled by each party to a case stating what his contentions will be of the trial. It also gives all such cletails as his apponent needs to know in order to propose his case and to answer the contentions put forward by the party going to cowd. It shall be remembered that no relief can be claimed on the grounds which are not contained in the pleadings. Therefore, it is very much essential to ensure that the pleadings shall set out all the material facts, only then the relief can be claimed on that basis. As far as possible vague description should be avoided in the pleading.

The main object of pleading is to ensure that both parties at dispute should know the exact points of dispute between them so as to being forward their own case of evidence to determine the issue. In other words, the function of pleadings is to ascertain with prucision, in matters on which the parties differ & the points on which they agree so as to arrive at certain clear issues on which both parties desire a judicial decision.

In India there are only two types of pleadings in a suit as defined in Order VI Rule I of Code of Civil Procedure, 1908. It states that pleading means plaint of written statement. The person who is presenting the plaint is called as the plaintiff. He will be presenting the plaint to get relief from the court In other words the person who commences an action against another person is called as plaintiff and the other person will be called as defendant. So defendant is the person against whom civil proceedings are drawn The term defendant is used in CPC with regard to a person who replies to the plaint in the form of written statement.

Plaint is a statement of defences in which the defendant plaintiff sets out his cause of action with all necessary particulars.

Written statement is a statement of defences in which the defendant deals with every material fact, alleged by the plaintiff in the plaint and also sets out any new facts which is in garage and also addings to such objections as he

	inference. For ex it is mot enough to state that the defendant is quilty of misconduct but facts which constitute the misconduct in the opinion of the plaintiff or the breach of that conduct should be very clearly stated in the pleading
	the court will examine and infer from that whether had been guilty of misconduct or not. The plaint should only state the facts leading to the cause of action against the defendant. In other words plaintiff is not required to plead the law under which he claims a decru and it is not essential for the defendant to mention the points of law in the written statement.
