ELIGIBILITY CRITERIA FOR ADMISSION

BA., LLB / BBA, LL.B 5 YEARS (INTEGRATED DEGREE)

(a) An applicant who has completed a Pre-University course or Senior Secondary School course ('4-2') or equivalent such as (11+1, 'A' level in Senior School Leaving Certificate Course)

(b) Minimum percentage of marks in qualifying examination shall not be below 45% (44.5% and above shall be treated as 45%) of total marks in case of General category applicants, 42% (41.5% and above shall be treated as 42%) for OBC category and 40% (39.5% and above shall be treated as 40%) of total marks in case of SC and ST applicants,

(c) Maximum age for seeking admission is limited to 20 years in the case of the General Category of applicants and to 22 years in the case of applicants from SC, ST, and other Backward communities.

THREE-YEAR LL.B. DEGREE PROGRAMME:

(a) An applicant who has graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State Legislature or an equivalent national institution recognized as a Deemed to be University or foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for a three-year degree course in law leading to the conferment of LL.B. degree on successful completion of the regular program-conducted under these Regulations.

(b) Minimum percentage of marks in qualifying examination shall not be below 45% (44.5% and above shall be treated as 45%) of total marks in case of General category applicants, 42% (41.5% and above shall be treated as 42%) for OBC category and 40% (39.5% and above shall be treated as 40%) of total marks in case of SC and ST applicants.

(c) Maximum age for seeking admission is limited to thirty years in the case of the general category of applicants and to thirty-five years in the case of applicants from SC, ST, and other backward communities.

TWO-YEAR LL.M IN BUSINESS AND TRADE LAWS

(a) An applicant who has graduated in law from a University established by an Act of Parliament or by a state legislature or an equivalent national institution recognized as a deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for LL.M degree course.

(b) Minimum percentage of marks in qualifying examination shall not be below 45% of total marks in the case of general category applicants and 40% of total marks in the case of SC and ST applicants.

(c) Govt. policy of reservation as applicable from time to time.

HOW TO APPLY

Eligible candidates are required to submit the prescribed application duly filled in with the following enclosures along with the Registration fee of Rs.100/- (by cash, or D.D) payable at Mangaluru, to The Principal, Shri Dharmasthala Manjunatheshwara Law College, Centre for Post Graduate Studies and Research in Law, M.G. Road, Kodialbail, Mangalore- 575003 The last date of registration shall be subject to the University Notification relating to admission.

- Certified copy of Pre-university Marks Card.
- Certified copy of passing certificate where applicable.
- Certified copy of S.S.L.C. for proof for date of birth.
- Certified copy of Conduct Certificate and Transfer Certificate
- Four recent Pass-port size photo without Signature. One to be pasted on the application.

FOR FIRST SEMESTER (3 YEARS)

- Certified copies of statement of marks of qualifying degree (3years)
- Certified copy of Conduct Certificate and Transfer Certificate
- Certified copy of Degree Certificate or provisional Pass Certificate.
- Certified copy of S.S.L.C. as a proof for date of birth.
- Four recent Passport size photos without signature. One to be pasted on the application.

ADMISSION

If the candidate is selected for admission, he/she will be informed by Post. He / She is required to produce the following certificates in original at the time of admission.

- Statement of Marks Cards of all the years for 3years course and II P.U.C./PDC or equivalent for 5 years course.
- Passing Certificate / Degree Certificate.
- Transfer Certificate issued from the College last studied.
- Conduct Certificate.
- Eligibility certificate issued by Karnataka State Law University, Hubballi.
- Migration Certificate issued from last studied University/Board.

ELIGIBILITY CERTIFICATE

Applicants who have passed the qualifying examination from other than the Universities located in Karnataka State/ Karnataka P.U. Board, must produce the Eligibility Certificate issued by the Registrar, Karnataka State Law University, Hubballi at the time of admission. This can be had from the University on submitting an application in the prescribed form enclosing the attested Xerox copies of the statement of marks S.S.L.C., Migration certificate with the fees prescribed by the Registrar, Karnataka State Law University, Hubballi. No admission can be made without this certificate.

ACADEMIC SCHEDULE

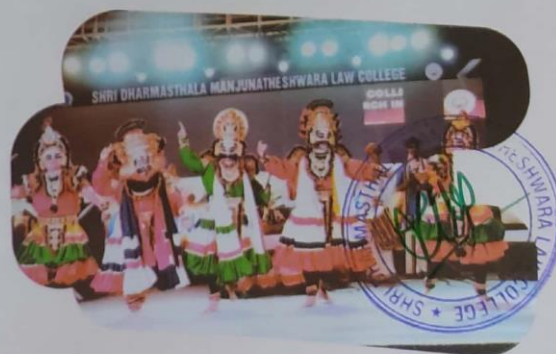
The academic year of the college begins in September/October. The semester examination of each semester of the course ordinarily commence in March and September. The tutorial hours 8-00am to 5-00pm.



FUNDAMENTAL RULES WITH REGARD TO PLEADINGS

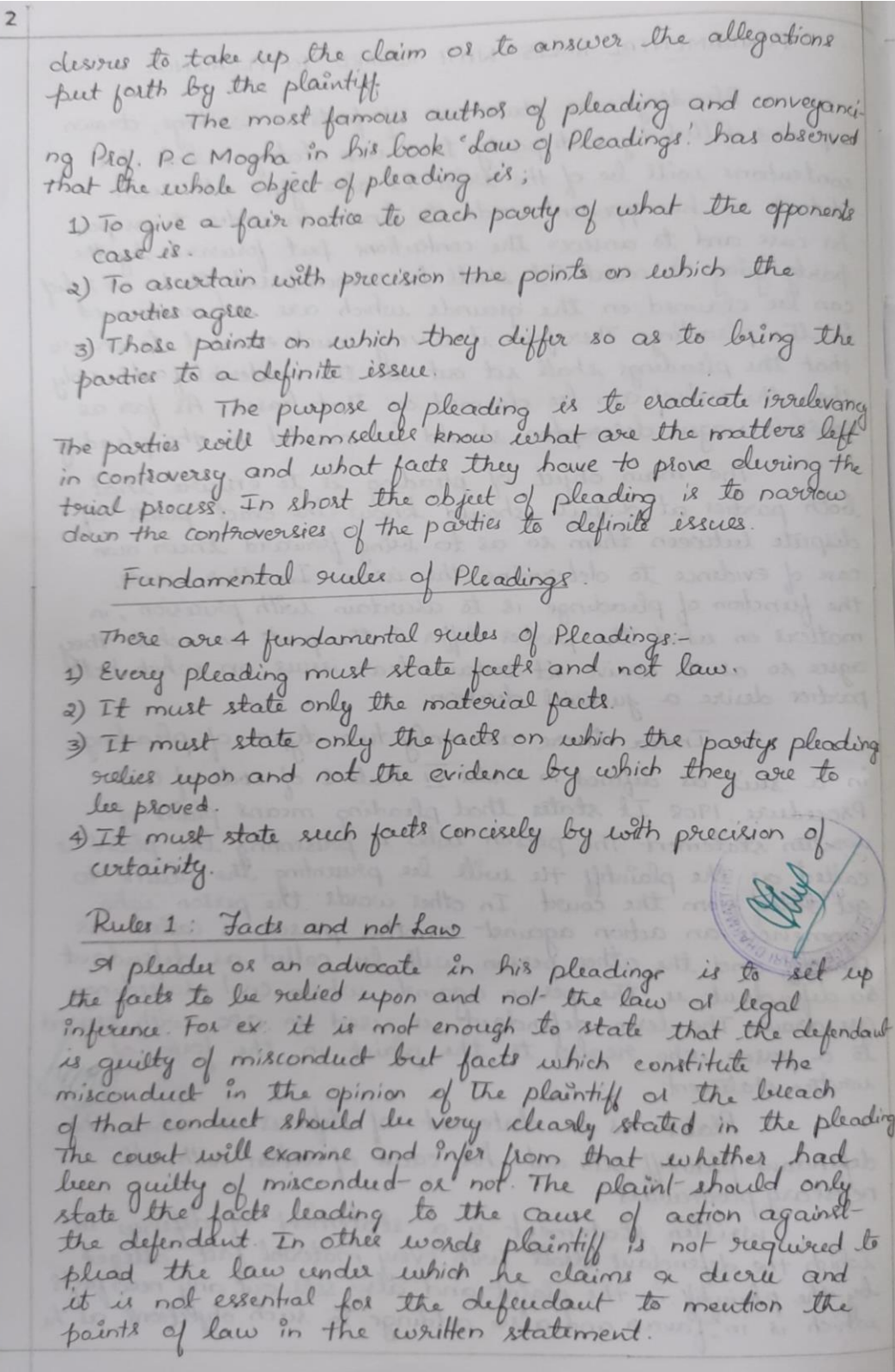
Pleadings are statements of facts in writings, drawn up and filled by each party to a case stating what his contentions will be of the trial. It also gives all such details as his opponent needs to know in order to propose his case and to answer the contentions put forward by the party going to court. It shall be remembered that no relief can be claimed on the grounds which are not contained in the pleadings. Therefore, it is very much essential to ensure that the pleadings shall set out all the material facts, only then the relief can be claimed on that basis. As far as possible vague description should be avoided in the pleading.

The main object of pleading is to ensure that both parties at dispute should know the exact points of dispute between them so as to bring forward their own case of evidence to determine the issue. In other words, the function of pleadings is to ascertain with precision, in matters on which the parties differ & the points on which they agree so as to arrive at certain clear issues on which both parties desire a judicial decision.

In India there are only two types of pleadings in a suit as defined in Order VI Rule 1 of Code of Civil Procedure, 1908. It states that pleading means plaint or written statement. The person who is presenting the plaint is called as the plaintiff. He will be presenting the plaint to get relief from the court. In other words the person who commences an action against another person is called as plaintiff and the other person will be called as defendant. So defendant is the person against whom civil proceedings are drawn. The term defendant is used in CPC with regard to a person who replies to the plaint in the form of written statement.

Plaint is a statement of defences in which the defendant plaintiff sets out his cause of action with all necessary particulars.

Written statement is a statement of defences in which the defendant deals with every material fact, alleged by the plaintiff in the plaint and also sets out any new facts which is in his favour and also addings to such objections as he





FACTS OF THE CASE

The respondent, advocate D, is a practicing advocate in the Bombay High Court. In 1953, the advocate was prosecuted before Mr. Sonawane, one of the Presidency Magistrate at Bombay, on having committed an offence under the Bombay Prohibition Act. The trial was from July 1953 to November 1953.

On 18-11-1953 the advocate was convicted by the magistrate of the offence of which he was charged, and sentenced him to rigorous imprisonment for a period of one month and a fine of ₹ 201. In addition to this, on default of payment of fine, rigorous imprisonment of 4 weeks were included.

The advocate then appealed to the High Court where where the High Court upheld the conviction but the sentence was altered to the fine of ₹ 100. On 24-02-1954. In the meanwhile, the trial court Magistrate, Mr. Sonawane made a report to a registrar of Bombay High Court regarding the conduct of the advocate who appeared in person as the accused. The Hon'ble Chief Justice of Bombay High Court constituted a tribunal consisting of three members of the Bar Council to enquire into the conduct of the advocate on 16-3-1955. The respondent pleaded guilty to the charges levied against him. The tribunal made a request to the Magistrate where on the respondent's own admission, it was held that the allegation in the report of Mr. Sonawane were

REASONS FOR JUDGEMENT-

1. The conduct of the advocate in the criminal trial against him in the court of magistrate was entirely improper by any standard. It disclosed a continuous attempt on the part of the advocate to be rude and contemptuous of the Magistrate to hold up the trial and to do everything in his power to bring the administration of justice in ~~power~~ contempt, such a conduct merits severe condemnation. The advocate ~~is~~ has indulged into a conduct unworthy of a member of the honourable profession to which he belonged and so he should be suspended from practice for the same time.
2. Being an advocate of the Supreme Court and entitled under the Supreme Court Advocates Act to exercise his profession in all courts in India any suspension for a period less than fixed by the Bombay High Court would lead to inconvenience. Hence, the advocate was suspended for a period of ~~no-~~ terms with the period of suspension fixed by the Bombay High Court.
3. The advocate pleaded guilty and admitted the correctness of the report against him by the magistrate. He also tendered an unconditional apology to the tribunal evidently in the hope that he would get away with it by merely tendering an apology.
The Supreme Court agreed with the observation of the Bombay High Court and the report of the Bench. It was observed that all the above-mentioned reasons were correct and upheld the judgment of the

to hold up the trial and do everything in his power to bring the administration of justice into contempt. Thus in the view of the conduct of the advocate, I support the opinion of the Supreme Court to suspend the advocate from practice. I also agree with the justification provided by the Hon'ble Court to uphold the period fixed by the Bombay High Court for the suspension as the advocate was entitled to practice his profession in any court throughout the Union of India and any period lesser would be irregular in nature.

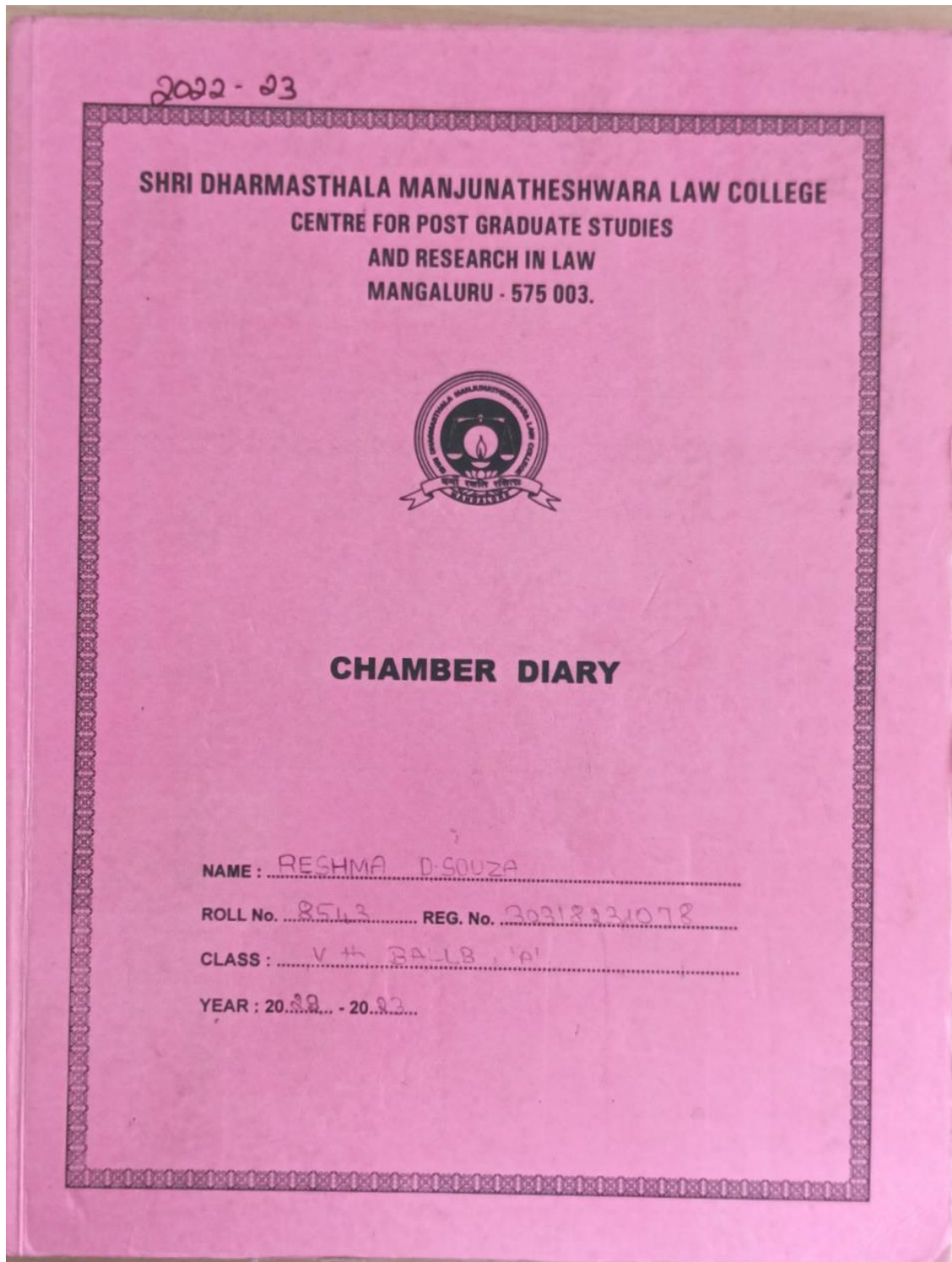

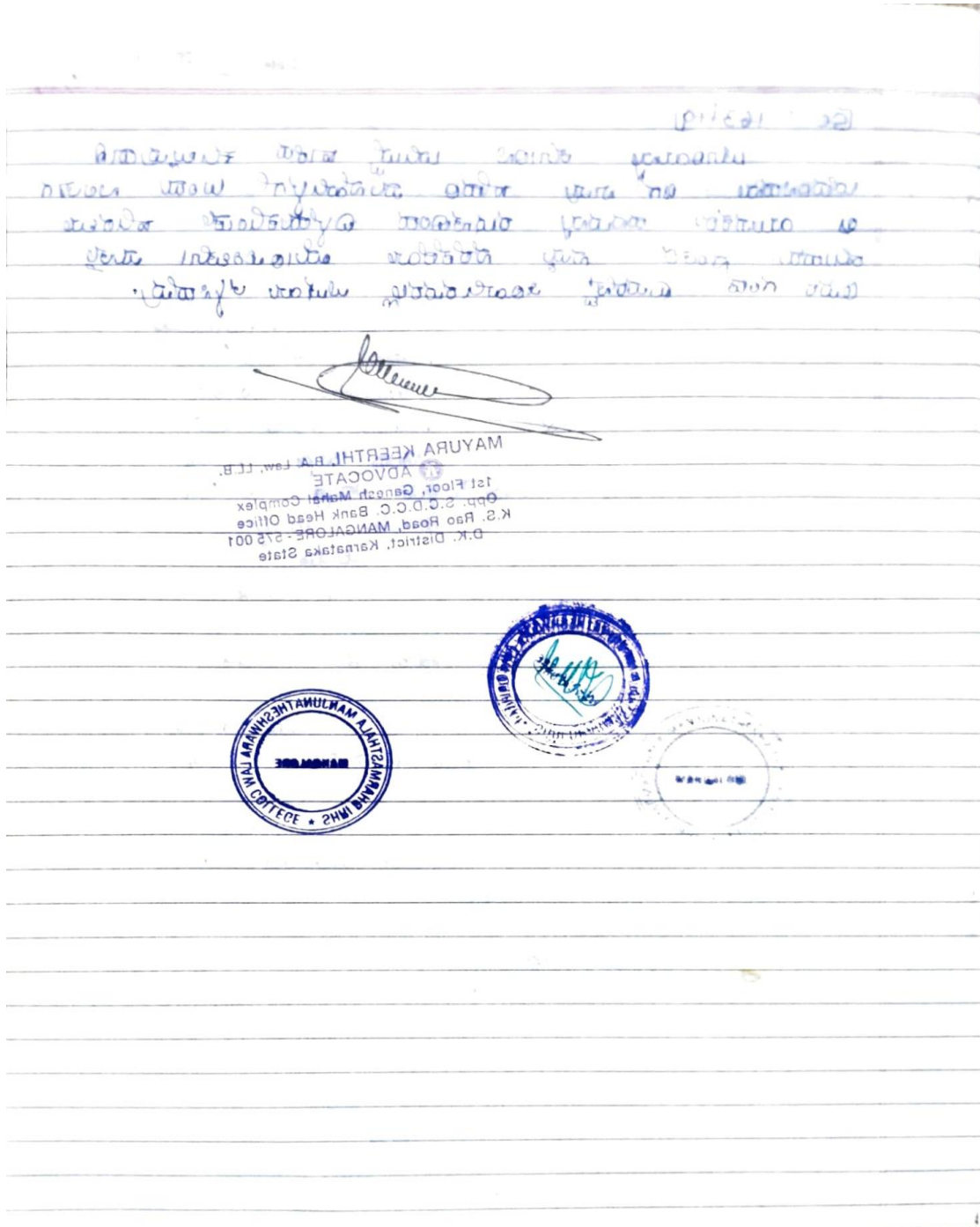

Brief facts of the case

The plaintiff is the landlord of the suit schedule property which is fully described in schedule 'A'. The defendant is monthly tenant. The monthly rent paid by him is RS 25,000/- It has to be paid on or before 5th of every month. There is a rent agreement/ lease agreement between the plaintiff and defendant for 11 months renewable with few changes. The defendant has also paid RS. 5 lakhs as deposit.

Even though the premises is located within Mangalore city Corporation the plinth area is more than 250 sqft and hence the K.R.P. 1999 is not applicable to this. Hence the suit has been filed before this Honourable court as original suit.

The defendant has been a monthly tenant from 2015-2021. After every 11 months a new lease agreement would be drafted.

The plaintiff comes to know that defendant has sub-letted the suit schedule premises and also creating nuisance by illegally dumping waste materials in the vacant adjacent land. The defendant is also arrears of rent from past 10 months. For all the above said reasons the plaintiff has decided to put an end to the lease by issuing a quit notice under section 106 of T.P. Act and also issued the letter of termination asking him to surrender the vacant possession of the suit schedule property.

The defendant states that in spite of several demands and also a letter dated 10/10/2021, the plaintiff has failed to take possession of the suit schedule property and to return the deposit amount of RS. 5,00,000/-.

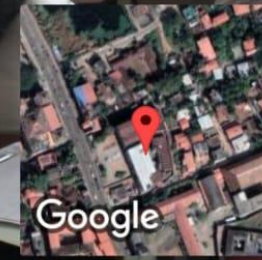

1. a) "Contract without consideration is void" According to Section 2 (d), "When at the desire of the promisor, promisee or any other person has done or abstained from doing, or does or abstains from doing, or promises to do or to abstain from doing something, such act or abstinence or promise is said to be a consideration to promise" "Ex Nudo Facto Non Oritur Actio" means "no right of action arises from contract entered into without the consideration". Consideration forms an essential part while making a contract. It is entirely based on the principle of 'Quid Pro Quo' which means something in return or something for something. Exceptions to the rule are:- According to Section 25 of Indian Contract, "agreement without consideration is void unless -

- It is put in writing and registered.
- or is a promise to compensate for something done.
- or is a promise to pay debt based





by the limitation law.

1) Sec 25 (i) - Promise due out of natural love and affection.

If the consideration is given out of natural love and affection, then such consideration is valid. The requirements are as followed:

- It should be given out of natural love and affection between the parties.
- The parties to the contract should stand in a near relation.
- It should be put in writing and should be registered.

Ex1: A gives B ₹ 100, this is not a valid consideration.

Ex2: A, father of B gives ₹ 100 to his son out of natural love and affection and puts it in writing and registers it. This is a valid consideration. It can be explained with the help of case study given below:

Rajlaky Dabee v. Bhoothnath Mukerjee

Here husband lived with wife and later separated from her and started to live with another lady. In such case, she asked him to provide maintenance. Since she kept on irritating him, husband agreed ^{and put in writing & register} to pay. After few months there was ^{no} payment. When wife sued husband, Court held that though ^{the} parties stood in near relation and it was put-



in writing and registered, it was not a valid consideration because husband had agreed to give it not out of natural love and affection. Therefore the contract was considered to be void.

2) Section 25 (2) - Compensation for past voluntary services.

If an act is done voluntarily and other party agrees to give something for helping, then such consideration is considered to be a valid one.

Ex 1: A finds the purse of B. B agrees to pay an amount to A for finding the purse. Here the consideration is a valid one.

3) Section 25 (3) - Promise to pay the time barred debt :

If a person promises to pay the debt by writing it on a promissory note, then consideration is a valid one. The conditions are as followed:

- Promise to pay wholly or in a part of the time barred debt.
- The promise has to be in writing.

Example : A has taken loan from B. But his debt is barred by the limitation Act. In such case, A signs a written note to pay ₹ 500 on account of his debt. Then it is considered to be a valid one.






It can be explained with the help of case study, given below:-

- Tulsibai v. Same Singh.

The facts of the case are as follows:-
A took loan from B for which he provided a promissory. But when the due date came, A was not in a position to pay it. The creditor, B went to A and made him to put in writing behind the promissory note that the amount will be paid within next one year.

Therefore, these are the exceptions to the statement that "Contract without consideration is void." The contract becomes complete when there is offer and acceptance and along with that consideration is also needed which plays prominent role in any contract. It should be something in the form of act or abstinence or promise and all these constitute a consideration.

Only when the consideration is real and not immoral, illegal or opposed to public policy, consideration is said to be a valid one.

II b) ^{Was no contract and there} In the above case, there is no breach of contract. ^{usually} because the contract is formed when the offer is made and ^{is} accepted. In this case, the contract ^{could be} is formed when A offers to buy the book and the B makes an acceptance by receiving the money. ^{So it was just an offer but no acceptance} But B had not accepted the offer. According to Sec 2 (b), Acceptance is,
"When a person to whom the proposal is made signifies his assent, there to, the proposal is said to be accepted. Thus when the proposal is accepted it becomes a promise."
The similar fact can be seen in the case of Pharmaceutical Society of Great Britain v. Boots Cash Chemist Ltd, where a customer chose a medicine which was displayed on the shelf of pharmacy and the medicine consisted some sort of drug dosage. When this was seen by a member of Pharmaceutical Society he filed the case towards the owner of the shop. But the medicine was supervised by the chemist and given to the customer. It was held that, it ^{in shelf} was just displaying of medicine, was just an offer but the contract becomes complete at the cash reception when payment is made the cashier and is accepted by him. Therefore to make the contract complete
