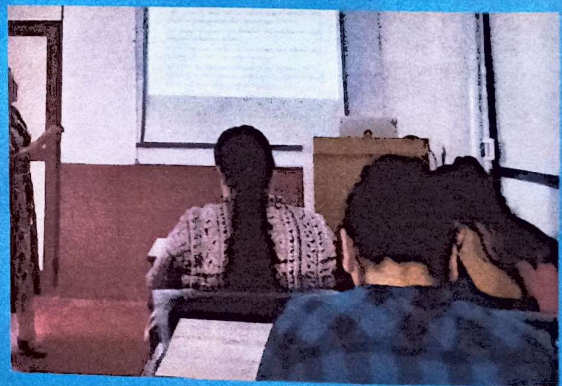
**MAJOR ACTIVITIES AND EVENTS :**

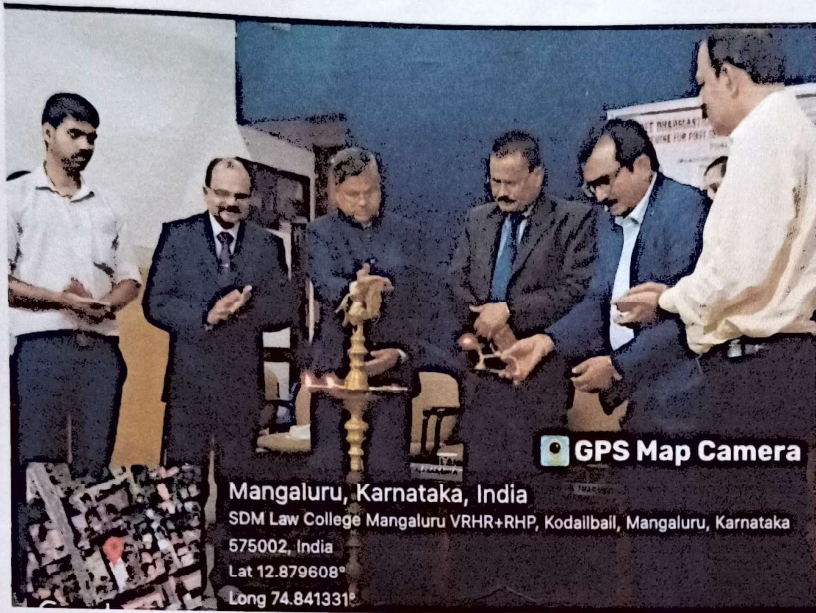


ALUMNI ASSOCIATION
