

## GENERAL MENORANDUM OF UNDERSTANDING (MOU) FOR ACADMIC AND RESEARCH COOPERATION BETWEEN

## MANIPAL ACADEMY OF HIGHER EDUCATION, MANIPAL AND

SHREE DHARMASTHALAMANJUNATHESHWARA LAW COLLEGE, CENTRE FOR POST GRADUATE STUDIES & RESEARCH IN LAW, MANGALORE, D.K.

The Manipal Academy of Higher Education, deemed-to-be-University under Section 3 of UGC Act, 1956, Manipal and Shree Dharmasthala Manjunatheshwara Law College Centre for Post Graduate Studies and Research in Law, Mangalore, establish this General Agreement to foster cooperation in education and research.

- 1. Both parties agree to encourage the following activities, in particular to promote academic cooperation:
  - a. Exchange of materials in education and research, publications, and academic information:
  - Exchange of faculty and research scholars;
  - c. Exchange of students;
  - d. Joint research and meetings for education and research;
  - e. Technical assistance;

Both parties shall discuss the problems involved to the satisfaction of each party and enter into specific activity agreements based on the mutually agreed objectives and outcomes of the relationship.

- This General Agreement shall be applicable to educational and research organizations attached to each party.
- This Agreement constitutes the entire agreement between the parties, and all prior discussions, agreements and understandings, whether verbal or in writing, is merged in this agreement.
- 4. This Agreement is not considered to be a contract creating legal and financial relationships between the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial exchange process/research relationship and so forth.
- This General Agreement shall become effective as on 01-05-2023 and executed on 01-05-2023. The Agreement may be amended by the written consent of the parties.
- 6. This Agreement should be reviewed every five years to evaluate the progress and the quality of the mutual cooperation. The Agreement may be extended for additional five year periods upon the written consent of both parties. If the Agreement is not renewed by mutual consent, the Agreement will conclude at the end of the specified time period or after activities in progress have concluded.

- This Agreement may be terminated by either party with a minimum of 120 days
  written notice. Activities in progress at the time of termination of this Agreement
  shall be permitted to conclude as planned unless otherwise agreed.
- Both institutions subscribe to a policy of equal opportunity and do not discriminate on the basis of race, color, gender, age, height, weight, marital or familial status, ethnicity, religion national origin or disability.
- 9. All disputes or difference arising between the parties as to the affect, validity or interpretation of this MOU or as to their rights, duties or liabilities shall be resolved by mutual discussion between representatives of Manipal Academy of Higher Education, Manipal and Shree Dharmasthala Manjunatheshwara Law College Centre for Post Graduate Studies and Research in Law, Mangalore
- 10. Neither Manipal Academy of Higher Education, Manipal nor Shree Dharmasthala Manjunatheshwara Law College Centre for Post Graduate Studies and Research in Law, Mangalore will be held responsible for any liability to the other party, and neither party shall be required to purchase any Insurance against loss or damage to any property due to activities to which agreement relates.

Each party shall designate a person or office to serve as liaison for implementing the projects undertaken as per this Agreement.

Every collaboration will have its own agreement/contract which addresses issues such as publications, IPR, funding pattern, disclosure of information etc. This has to be based on the mutual discussion and agreement finalized by the concerned people involved in it.

#### SCOPE OF AGREEMENT

- 5. Students, Research Scholars and Teaching Faculty of both Institution will explore possibility of taking up collaborative research work/projects/training, internship and placement related activities and also apply for funding from national and international agencies, governments and other funding agencies;
- 6. Any financial implication emerging out of such collaborations (other than the fees of the students etc.) shall be worked out and decisions will be taken with mutual agreement.

#### IV. INTELLECTUAL PROPERTY AND CONFIDENTIALITY

- 1. In respect of each project and programme of co-operation, the parties shall negotiate and mutually agree in writing on their respective rights to intellectual property and commercial exploitation of the same (including without limitation, trademarks and service marks, copyrights, patents, designs and confidential information pertaining thereto).
- 2. Neither party shall, at any time disclose to any third party any confidential information of the other party which is acquired in the course of activities under this Memorandum, a collaborative project or a programme, without the prior consent of the other party in writing.

The confidentiality obligations herein will not apply to information in the public domain; information in the possession of the receiving party prior to the disclosure of the information; information which is independently developed by the receiving party; information required to be released by law; and information which is rightfully received by the receiving party from third parties without any breach of confidentiality obligations.

The Patient whose kidneys are failed need to undergo dialysis and it cost around 1500 per heamo dialysis and the same need to be done three times a week and 53 times a year which cost around 2.5 lakhs per patient. If kidney is donated to the dialysis patients their lives will be saved and they need not undergo dialysis every time.
- 3. A single donor can save the lives of at least 50 donors.
- 4. There are six steps/procedures for the donors:
- a) Brain dead identification by treating physician.
- b) Counsels the relatives for transplantation.
- c) Report to state authorization coordination committee.
- d) Donor's health maintenance.
- e) 1st declaration by donors.
- f) Legal formalities.

- 5. He spoke about the preservation of organs such as head for 3-4 hours, liver for 4-6 hours, pancreas for 4-7 hours and kidney for 6-8 hours.
- 6. Organ donation can be done post cardiac death.
- 7. He spoke about creation of awareness in the public and for this media plays an important role.
- 8. He said, counselling the family of brain-dead person is very important for organ donation of a brain-dead person.
- 9. For those who donate the organs to the family and patients suffering from organ failure he quoted that, "Heaven do not need organs, but those organs can make heaven on earth".
- 10. Finally, he ended the special lecture with a short film made by him on organ donation.

The special lecture was very informative and the students learned the importance organ donation and saving the lives of needy person and their family.
